EU Directive 2011/65 / EU Delegated Directive (EU) 2015/863

Dear Sirs,

Thank you for your interest in our products. Referring your request, we can inform you as follows:

The RoHS Directive 2011/65 / EU, will be supplemented by 4 further substances in the form of Directive (EU) 2015/863 with effect from 22.07.2019.

In principle, ESKA Erich Schweizer GmbH respects national and international laws, applicable directives, standards and regulations, and at the same time continuously monitors all changes, such as the scope, CE marking or expiration dates of exceptions.

According to the new directive, RoHS conformity is now an integral part of the CE declaration and, with affixing of the CE marking on the product or on the packaging, RoHS conformity is automatically certified accordingly.

We ensure that our CE marked products are RoHS compliant and comply with the requirements of Directive 2011/65 / EU & (EU) 2015/863.

We take our duties very seriously in our own interests and under the aspect of the greatest possible product and delivery security.

The following procedure supports compliance with applicable regulations and legal regulations:

Our suppliers undertake to comply with substance bans and declaration obligations in accordance with RoHS. Transparency, intensive cooperation based on partnership and a lively exchange of information form the basis of our business relationships. In doing so, we ensure that delivered parts meet our and legal requirements.

Newly developed ESKA products and such covered by the RoHS Directive, are generally RoHS compliant.

Products are generally tested for compliance with the limits and compliance with annex III exemptions, and are noted RoHS compliant in our documentation and publications.
