Battery-free design

The Bell4U B101 kinetic wireless doorbell set is designed without batteries. The push button generates the energy required to transmit the wireless signal through the kinetic action of pressing the button. The receiver is plugged directly into a suitable wall socket and is powered from the mains supply. No battery or button cell is included in, or required for, the operation of either the push button or the receiver. Consequently, the complete doorbell set is battery-free and the battery-specific product requirements of Regulation (EU) 2023/1542 do not apply to this product.

Waste electrical and electronic equipment

The product and the producer's declarations, registration and reporting relating to waste electrical and electronic equipment are declared to comply with Directive 2012/19/EU on waste electrical and electronic equipment (WEEE), as amended, and with the applicable national implementation requirements.
