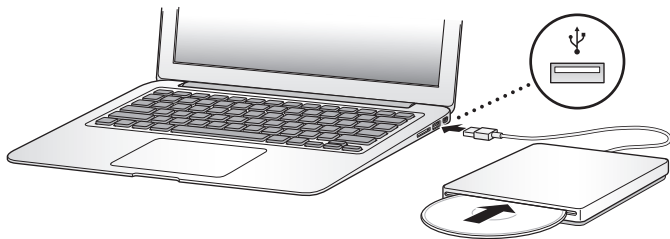

# Apple USB SuperDrive



Choose Software Update from the Apple menu () to update your system software to the latest version. Attach the Apple USB SuperDrive to a USB port on your computer. Do one of the following to eject a DVD or CD:

- Select the DVD or CD, and choose File > Eject from the menu bar.
- Click Eject (⏏) next to the DVD or CD name in the sidebar of a Finder window.
- Drag the DVD or CD to the Trash icon in the Dock.
- Press the Media Eject key (⏏) on the keyboard (if your keyboard has one).

You can eject a DVD or CD only when the drive is connected to your computer.

アップル (🍏) メニューから「ソフトウェア・アップデート」を選択し、システムソフトウェアを最新のバージョンにアップデートします。Apple USB SuperDrive をお使いのコンピュータの USB ポートに直接接続します。DVD や CD を取り出すには、以下のいずれかを実行します：

- DVD または CD を選択し、メニューバーから「ファイル」>「取り出す」と選択する。
- Finder ウィンドウのサイドバーに表示されている DVD 名または CD 名の横の「取り出す」(⏏) をクリックする。
- DVD または CD を Dock のゴミ箱アイコンにドラッグする。
- キーボードにメディア・イジェクト・キー (⏏) がある場合は、そのキーを押す。

DVD や CD は、ドライブがコンピュータに接続されているときのみ取り出せます。

Dans le menu Pomme (🍏), sélectionnez « Mise à jour de logiciels » pour obtenir la dernière version de votre logiciel système. Connectez votre lecteur Apple USB SuperDrive à un port USB de votre ordinateur. Pour éjecter un DVD ou un CD, effectuez l'une des opérations suivantes :

- Sélectionnez le DVD ou CD et choisissez Fichier > Éjecter dans la barre des menus.
- Cliquez sur Éjecter (⏏) en regard du nom du DVD ou CD dans la barre latérale de la fenêtre du Finder.
- Faites glisser le DVD ou CD sur l'icône Corbeille du Dock.
- Appuyez sur la touche d'éjection de disque de votre clavier (⏏) (le cas échéant).

Vous pouvez éjecter un DVD ou un CD uniquement lorsque le lecteur est connecté à votre ordinateur.

Wählen Sie „Softwareaktualisierung“ aus dem Menü „Apple“ (🍏), um Ihre Systemsoftware auf die neueste Version zu aktualisieren. Schließen Sie das Apple USB SuperDrive-Laufwerk direkt an einen USB-Anschluss Ihres Computers an. Führen Sie einen der folgenden Schritte aus, um eine DVD oder CD auszuwerfen:

- Wählen Sie die DVD oder CD aus. Wählen Sie dann in der Menüleiste „Ablage“ > „Auswerfen“.
- Klicken Sie neben dem Namen der DVD oder CD in der Seitenleiste des Finder-Fensters auf „Auswerfen“ (⏏).
- Bewegen Sie die DVD oder CD auf das Papierkorbsymbol im Dock.
- Drücken Sie Medientast (⏏) auf der Tastatur (sofern auf Ihrer Tastatur vorhanden).

Eine DVD oder CD kann nur ausgeworfen werden, wenn das Laufwerk an Ihrem Computer angeschlossen ist.

Seleccione “Actualización de software” en el menú Apple (🍏) para actualizar el software del sistema a la versión más reciente. Conecte la unidad Apple USB SuperDrive directamente a cualquier puerto USB de su ordenador. Para expulsar un DVD o CD, realice una de las siguientes operaciones:

- Elija el DVD o CD y seleccione Archivo > Expulsar en la barra de menús.
- Haga clic en Expulsar (⏏) junto al nombre del DVD o CD en la barra lateral de la ventana del Finder.

- Arrastre el DVD o CD hasta el icono de la Papelera en el Dock.
  - Pulse la tecla de expulsión de discos (⏏) en el teclado (si su teclado dispone de ella).
- Para poder expulsar un DVD o CD, la unidad debe estar conectada al ordenador.

Escolha a Atualização de Software no menu Apple (🍏) para atualizar o software do seu sistema para a última versão. Conecte a unidade Apple USB SuperDrive diretamente a uma porta USB no seu computador. Para ejetar um DVD ou CD, realize uma das seguintes opções:

- Selecione o DVD ou CD e escolha na barra de menus: Arquivo > Ejetar.
- Clique em Ejetar (⏏) ao lado do nome do CD ou DVD na barra lateral de uma janela do Finder.
- Arraste o DVD ou CD para o ícone do Lixo no Dock.
- Pressione a tecla Ejetar Mídia (⏏) no teclado (caso seu teclado possua uma).

Você pode ejetar um DVD ou CD somente quando a unidade estiver conectada ao seu computador.
