Meller limited warranty

Meller sunglasses are warranted for one year from the date of purchase from manufacturer's defects. This warranty is valid only to the original client with a proof of purchase from an Authorized Meller distributor. Meller does not warrant from lens scratches. Alteration, misuse, abuse or installation of non- Meller lenses will disable this warranty. The only compensation that will the customer receive if the warranty is needed, it is the repair or replacement of the item as determined by Meller. This warranty does not affect the legal rights of customers under any state or national applicable laws governing the sale of consumer goods.

How to make a warranty claim

Customers should contact the authorized distributor through which they have completed the purchase. Unless specifically stated the contrary by Meller, to make a warranty claim, you should return your product to Meller's authorized distributor together to the proof of purchase. Any expenses incurred in returning the product for warranty assessment will be done at the client expense at first. If your claim is deemed to be valid, Meller will replace or repair de product and also incur with all the transportation costs related to the warranty. If the warranty claim is deemed to be invalid, we will contact you to understand if you want us to repair the product at your cost and, in any event, you will be charged for the outbond freight based on Meller standard shipping rates.
