5. The object of the declaration described above is in conformity with the relevant Community harmonisation legislation:

6. Risk of assessment:

- Area of risk: Product contains polyester filling
Consumer type: Baby from 0 year old
Injury scenario: A baby is playing the toy. The polyester filling leaks and the baby puts the polyester filling in the mouth. The polyester filling goes into the baby's throat and makes the baby choke.
Mitigation: Test results support that both fabric and seams are strong, and quality control in production ensure that sewing has continuous high quality. Extra test of main production is made on a continuously basis.
- Area of risk: Packaging is impermeable to air
Consumer type: Baby from 0 year old
Injury scenario: A baby is playing with the plastic packaging of the toy. The child places it over the mouth and nose. The child is unable to remove the plastic packaging. The airflow is temporarily blocked.
Mitigation: Warning text at obvious position on the plastic bag.
- Area of risk: Product contains small parts
Consumer type: Baby from 0 year old
Injury scenario: A child is playing with the toy and the rattle or crackling from inside are detached from the body. These small parts come off and the child puts them in the mouth. The child accidentally swallows them.





Mitigation: Test results support that sewing is strong, and quality control in production ensure that sewing has continuous high quality. Extra test of main production is made on a continuously basis.

- Area of risk: Product contains harmful substances

Consumer type: Baby from 0 year old

Injury scenario: A child is playing with the toy and substance from fabric or dye is dissolved and absorbed by the child.

Mitigation: fabrics and dyes are tested for problematic substances according to toys directive EN71-3. The products are made from GOTS certified organic cotton, this is a further guarantee for no artificial chemicals in fabric and dye.
