

IMPORTANT SAFETY INSTRUCTIONS READ CAREFULLY AND STORE FOR FUTURE USE.

- Before connecting this appliance to a wall socket, make sure the voltage stated on the rating label of the appliance corresponds to the voltage in your wall socket.
- This appliance is designed for grinding coffee beans. The appliance can be used at home, in the
 office, etc.
- Do not use the appliance in industrial surroundings or outdoors!
- Do not place the appliance on unstable surfaces.
- Only place the appliance on an even, dry and stable surface.
- Ensure that the power plug contacts do not come into contact with water or moisture.
- Do not spray the appliance with water or any other liquid. Never wash it under running water or submerge it in water or another liquid.
- Do not turn on the appliance when it is empty. The incorrect use of the appliance may negatively
 affect its lifetime.
- The maximum continuous operating time is 30 seconds. After 30 seconds of continuous operation allow the appliance to rest for 2 minutes.
- Always turn off the appliance and disconnect from the power socket if you will not be using it and
 if you are leaving it without supervision, before mounting or removing the lid and before cleaning.
- Do not place the appliance on an electric or gas stove or in its vicinity, do not place it in the vicinity
 of an open fire or an appliance that is a source of heat.
- Do not place heavy items on the power cord. Make sure the power cord does not hang over the edge of a table or that it does not touch a hot surface.
- Do not disconnect the appliance from the power socket by pulling on the power cord. This could damage the power cord or the power socket. Disconnect the cord from the power socket by gently pulling the plug of the power cord.
- If the power cord is damaged, have it replaced at a professional service centre. It is forbidden to use the appliance if it has a damaged power cord or plug.
- To avoid the danger of injury by electrical shock, do not repair the appliance yourself or make any
 adjustments to it. Have all repairs or adjustments of the appliance performed at an authorised
 service centre. Tampering with the appliance during the warranty period may void the warranty
 policy.

DESCRIPTION OF THE COFFEE GRINDER

BEFORE FIRST USE

- 1. Remove the coffee grinder from the packing material.
- 2. Remove the lid A① by turning it anticlockwise. Wash the lid A① under running water using kitchen detergent. Then rinse it under running water and dry thoroughly. Wipe the hopper A② and the grinding blade A③ with a lightly dampened wiping cloth and then wipe it until it is thoroughly dry.



▲ Attention:

When cleaning the grinding blade A3, be very careful not to injure yourself with it.

USING THE COFFEE GRINDER

- 1. Wind the power cord out of the storage area A[®].
- 2. Remove the lid A① by turning it anticlockwise. Pour coffee beans into the hopper A②. The maximum capacity of the hopper A② is 60 g. Do not fill it up above the edge.
- 3. Place the lid A① on to the hopper A② and turn it clockwise until you hear an audible click. Now the lid A① is locked in place and will not come off by itself.
- 4. Connect the coffee grinder to an el. power socket and press the pulse button A(s) to start the coffee grinder. The coffee grinder will continue to run while the button A(s) is pressed. The coarseness of the ground coffee can be regulated by the grinding time. The longer you grind it, the finer it will be.



Attention:

The coffee grinder is equipped with a safety feature that prevents its operation if the lid is not correctly attached.

The maximum continuous operating time is 30 seconds. After 30 seconds of continuous operation allow the coffee grinder to rest for 2 minutes.



Tip:

Always prepare your coffee beverage from freshly ground coffee. Coffee that is ground in advance loses its flavour and aroma.

- 5. To end the operation, release the pulse button A(s). Disconnect the coffee grinder from the el. power socket. Turn the lid A(1) anticlockwise to release it, then take it off. Tip the ground coffee into a suitable container.
- 6. If you wish to grind another batch of coffee, repeat the above procedure.
- 7. Always disconnect the coffee grinder from the el. power socket after finishing using it and clean it out according to the instructions contained in the chapter Cleaning and maintenance.

CLEANING AND MAINTENANCE

- Before cleaning the appliance, disconnect it from the power socket.
- Clean the lid A① using warm water with kitchen detergent after every use. Then rinse it with clean water and dry thoroughly with a fine wiping cloth.
- Clean the remaining ground coffee out of the hopper A② and off the grinding blade A③. Then wipe with a dampened wiping cloth and then thoroughly wipe it out until dry.



Attention:

When cleaning the grinding blade A3, be very careful not to injure yourself with it.

- Use a dry or dampened wiping cloth for cleaning the base unit A4.
- Never submerge the base unit in water or any other liquid.
- Do not use solvents or thinners, abrasive cleaning products, etc. for cleaning any part of the
 appliance. Otherwise the surface coat of the appliance may be damaged.

STORAGE

• If you will not be using the appliance, store it in a dry place out of children's reach. Prior to storing the appliance, wind up the power cord into the storage area A® and close the lid A① so that dust does not accumulate inside the hopper A②.
