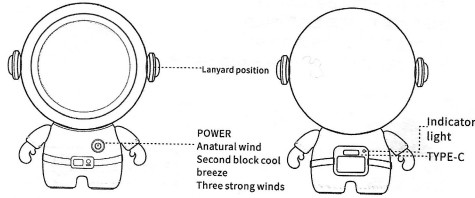


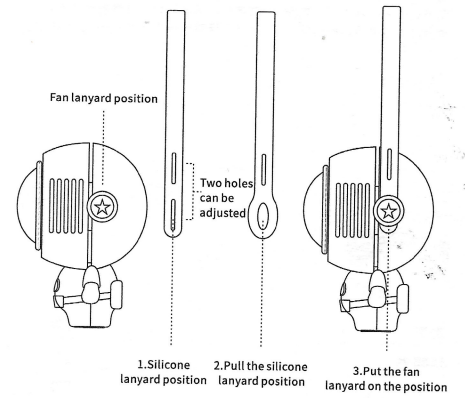

How to charge

The red indicator light is on during the charging process, and the red indicator light is off when the battery is fully charged and red when the battery is low. The indicator light flashes, flashing once per second, and the red indicator light flashes 3 times quickly when the battery is turned off, and then the machine is turned off.
