Note: Please keep these instructions in a safe place. Your next holiday is quite certain!

Dear user,

Congratulations, you are now the proud owner of a GARDENA Holiday Watering Set.

The Holiday Watering Set has been developed for automatic watering of your pot plants during your absence (e.g. when you are on holiday). But it can also be used for watering plants on patios and terraces.

The following instructions will help you to properly use your Holiday Watering Set. Therefore, please read these operating instructions carefully.

We have split up the operating instructions into two parts. In the first part, you will find instructions for installation and operation. The second part provides technical data as well as important safety instructions.

1. What will the Holiday Watering Set do for you?

Just imagine an automatic watering can which does your work during your absence. The Holiday Watering Set includes a pump transporting water from a container to the individual plants for one minute per day.

You can water up to 36 plants. It is up to you to determine the amount of water supplied to your plants every day. To get a feeling for the right amount of water, we recommend to you to install and test the system some days before leaving on holidays.

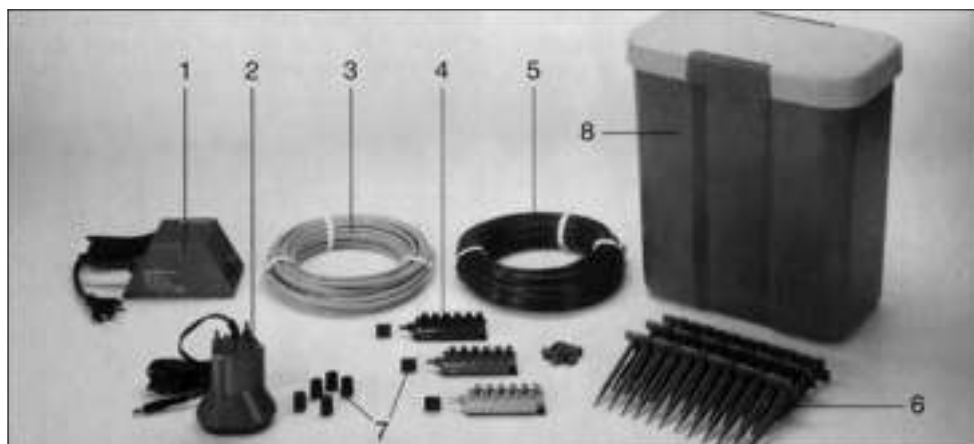
See the photo below for a completely installed system.



2. What are the components of the Holiday Watering Set?

Take all the components out of the carton and lay them out in front of you as shown on the photo.

1. Transformer with timer
2. Pump (14 V low-voltage)
3. Distribution pipe (\varnothing 4 mm)
4. Drip distributors 1–3 (light, medium and dark gray) with plugs
5. Drip pipe (\varnothing 2 mm)
6. Pipe pegs
7. Nuts and sealing plugs
8. Container (9 l) only for Art. No. 1266



3. What needs to be done before installation?

You have acquired an automatic watering can. Before installing your system, estimate roughly how much water you give regularly to your plants. You will see that there are great differences. So, form three groups of plants corresponding to the watering needs. Just as shown on the photo.

Note: When grouping the pots, ensure that they are placed above the water level of the container.

This prevents that the water flow continues after the pump has switched off. Also, ornamental pots and pans should be large enough to catch excessive water.

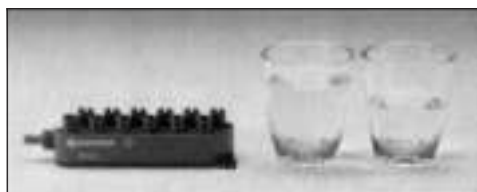


After having grouped your pot plants, each group is assigned a drip distributor.

The light grey drip distributor 1 has been developed for plants with low water demand and delivers approx. 15 ml **per outlet** every day.



The medium grey drip distributor 2 for plants with normal water demand delivers approx. 30 ml **per outlet** every day.



And for the plants with high water demand, you have the dark grey drip distributor 3. It delivers approx. 60 ml **per outlet** every day.



So, please remember:

light grey drip distributor 1

approx. 15 ml per outlet every day
for plants with low water demand

medium grey drip distributor 2

approx. 30 ml per outlet every day
for plants with normal water demand

dark grey drip distributor 3

approx. 60 ml per outlet every day
for plants with high water demand

Note: When grouping together your plants, choose a place which is not too close to the window so the plants are not exposed to direct sunlight. It is best to place them about 1 m away from the window.

In addition, do not forget that the water demand of individual plants can change when they have been moved. At bright, warm places they need more water than at shady, cool places.

4. Installation

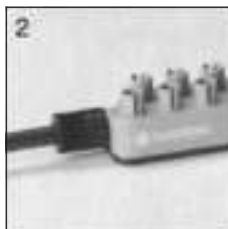
First, connect the drip distributors to the pump (2) using the 4 mm thick distribution pipe (3).

On closer inspection of your pump you will see that it has three connections, one for each drip distributor.

Cut the distribution pipes to size with a normal pair of scissors. The length of each pipe is the distance between the pump (take into account the location of the water container) and the individual drip distributors for each group of plants.

Now you need the nuts included in the Holiday Watering Set. Put one end of the pipe through the nut so that the thread points to the end (ill. 1). Push the end over the connection on the drip distributor and tighten the nut (ill. 2). Connect the pipe in the same way to the pump.

If not all drip distributors are required, please seal off the unused pump outlets with the plugs supplied (ill. 3).



Now install the drip pipes (5) (pipe with smaller diameter). Cut the drip pipes to size. The length is the distance between the drip distributor and the corresponding plant pot. We recommend to cut the water outlet end diagonally as this will allow a better flow (ill. 4). Click that end onto one of the three fixing devices at the pipe peg (6). Then put the pipe peg into the plant pot (ill. 5).

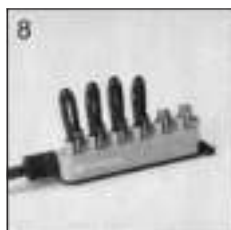


Cut the other end straight and push it over one outlet of the drip distributor as shown in the picture. Take care that the hose end fits tight (Ill. 6).

Use the enclosed plugs to seal those outlets on the drip distributor which are not in use. Simply plug them firmly onto the outlets (Ill. 7).



If the enclosed 20 plugs are not sufficient, you can solve the problem by connecting those outlets not in use with a short piece of drip pipe, as shown in Ill. 8.



After having installed the drip pipes for one group of plants, you should have a similar configuration as shown in the opposite photo (Ill. 9). Now you can continue to connect also the other plant groups to your watering system in the same way.



5. Water container

5.1. For those who do not have the GARDENA Water Container

You have now almost completed your task. You now need a water container, and for making a test run you need nothing more than a simple bucket.

For your holidays you may need a larger container. It is very easy to calculate the size. When using all 30 outlets of the three drip distributors, you need approx. 1.3 l of water per day.

How many days are you absent?
Multiply the number of days by 1.3 in order to get the litres of water needed.

Example: 21 days vacation (you're lucky!) means $21 \times 1,3 = 27,3$ l.

In this example, you could use for instance a washtub.

Remember evaporation will occur and to counteract this you will need to provide a little more water than calculated. This will also prevent damage to the pump caused by dryrunning due to a lack of water.

Hint: Reduce the natural formation of algae by protecting the water from light (for instance cover the container with a towel).

5.2. For those who have the GARDENA Water Container

The GARDENA Water Container (8) is sufficient for approximately one week if the system is fully used, i. e. if all outlets of the drip distributors are in use. If you are away from home for a longer time, please see point 5.1.

The cover has a small outlet through which the distributor pipes and the pump cable are passed (ill. 10).



6. Operation

Now the great moment comes. Fill the container with water and connect the pump to the transformer (1) (ill. 11).

**⚠ Never connect the pump to another transformer or directly to the power mains!
Place the transformer at a safe, dry place.**

Put the pump into the water (ill. 12). Take care that the pump stands firmly on the bottom of the container. When the plug belonging to the transformer is placed into the socket the pump starts to operate and runs for approximately one minute. Check that all connections are leak-free.

⚠ To prevent damage of the pump, never operate your pump without water.

To start your system again, pull the transformer plug from the socket and connect it again. This is also the way to determine the start time of your system.

Every 24 hours the system starts automatically for one minute. You determine the start time by connecting the transformer to the mains.



Example: You activate your system at 4.00 a.m. This means that your plants will be watered every day at 4.00 p.m. for one minute.

Note: The pump is activated even when the power supply has been interrupted, e.g. after a power failure during a thunderstorm. In this case, the start time would change but the function of the system would not be affected.



Watch your system for some days. Change the assignment of the plants to the different drip distributors, if necessary.

Hint: Plants react better to a lack of watering than to excessive watering. Correct your drip pipe configuration, if one hour after watering there is still water in the pan.

If you have plants with a very low water demand, you can water several plants via one drip pipe. For this, put the plants (which cannot absorb moisture) into a large pan and fix the drip pipe so that the water drips into the pan. See Ill. 13.



Of course, you can also water one plant with high water demand via several drip pipes (ill. 14).

7. Maintenance

The system is almost maintenance free. When you stop the operation of the system, the foam-plastic filter of the pump should be cleaned. For this, remove the orange base of the pump by pressing the lateral lock, take out the sieve (ill. 15) and rinse it in clear water.

When dismantling the system, remember that there is still some water in the pipes. Simply lift the drip distributors slightly and let the remaining water run into the pots.



8. And if ...

... no water is pumped?

Clear the sieve of the pump (see point 7).

... the water flow continues after the pump has switched off?

In this case, at least one of the drip pipe ends is below the water level of the container. Place the pots in such a way that they are above the water level of the container.


... you need additional parts for operating your system next time?


Just contact our Customer Service whom can order every single component, including the pipes. (For the address, see last page.)


... the outlets of a drip distributor are not sufficient for watering the plant group?


Use the next smaller drip distributors and connect to your plant pot twice the number of drip pipes planned for the original drip distributor (one outlet of the dark grey distributor 3 corresponds to two outlets of the medium grey drip distributor 2, or to four outlets of the light grey drip distributor 1).


9. Safety instructions

 For safety reasons children under the age of 16 or people not familiar with these operating instructions must not use the Holiday Watering Set.


 When performing any work on the GARDENA Holiday Watering set, disconnect the plug-in power supply from the mains.


 Always use Original GARDENA parts, otherwise proper function of the system cannot be guaranteed.

 The pump may only be operated at a low voltage of 14 V in conjunction with the GARDENA plug-in power supply with timer.

 Check the cable regularly for damage. Plug and cable may be used only in faultless condition. If the cable is damaged, disconnect the plug immediately.

Connecting the system directly to the 230 V power supply will cause serious injury or death!

 Damaged cables cannot be replaced.

 Never operate the pump without water!

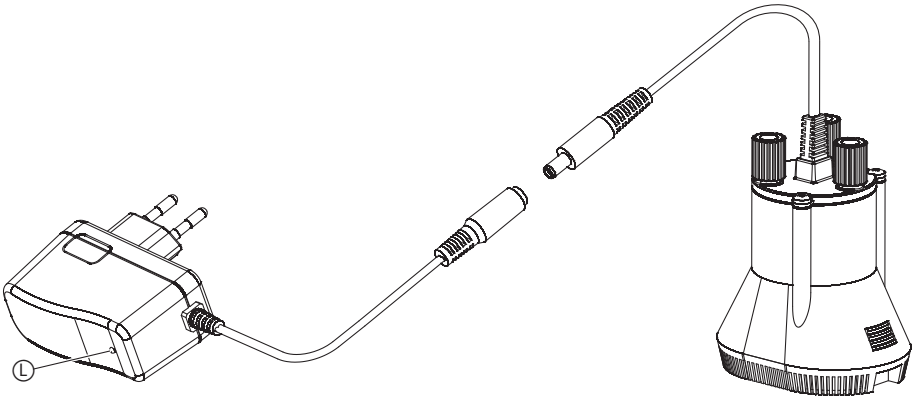
