**BRIEF DESCRIPTION**

Traditionally used by ancient Egyptians to detox and maintain their health and vitality, wheatgrass is the leafy growth of the young wheat plant. Nicknamed “liquid gold” one serving of wheatgrass juice is the rough equivalent of one and a half pounds of leafy green vegetables. Wheatgrass is an excellent source of minerals, boasting a wealth of magnesium, chlorophyll, calcium, copper and phosphorous content. Wheatgrass exhibits a significant proportion of essential vitamins. Sourced from an organic plant in Canterbury New Zealand, the wheatgrass plant is harvested whilst it is still young and transported to an organically certified dehydrating company. The moisture content of wheatgrass is reduced by 4%; wheatgrass is then ground to fine powder. This process preserves the nutritional integrity of the plant.

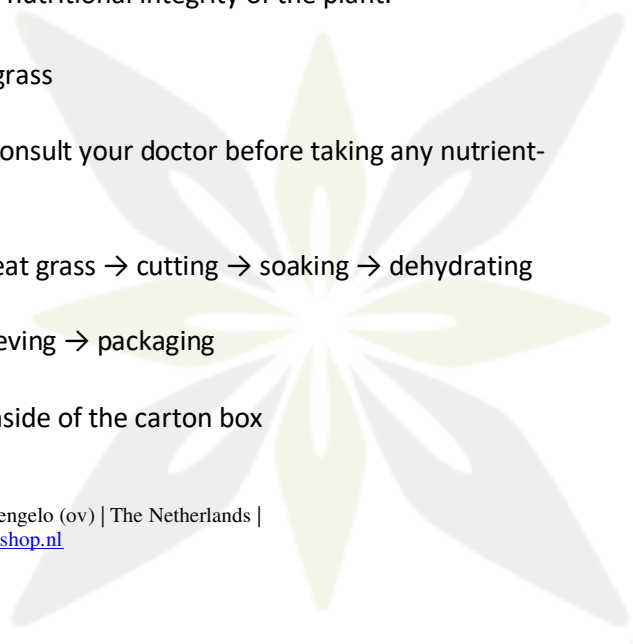

We hereby certify that Wheatgrass powder sold by VehGro does not contain any substances causing allergies or intolerances as ingredients. However, there is a remote possibility of cross contamination by gluten (please see explanation below). The list of allergens which are likely to cause adverse reactions in susceptible individuals is provided in Annex IIIa of Directive 2007/68/EC. Please note that this statement is based on the information provided by the manufacturer of the product.

While Barley Grass and Wheatgrass in their pure forms are considered gluten-free, it matters how they're harvested and how products containing them are produced. Gluten is contained in the seed of the wheat and Wheatgrasses. Therefore, if a farmer allows some of the grasses to begin producing seeds prior to harvest, then that particular crop will contain gluten or have gluten exposure. While our grass powders are from quality, respected sources, and we do not believe they are harvested with any seeds, we recommend that anyone with celiac's disease or gluten-free diet issues avoid any product containing Barley or Wheatgrass that's not specifically tested to be gluten-free.

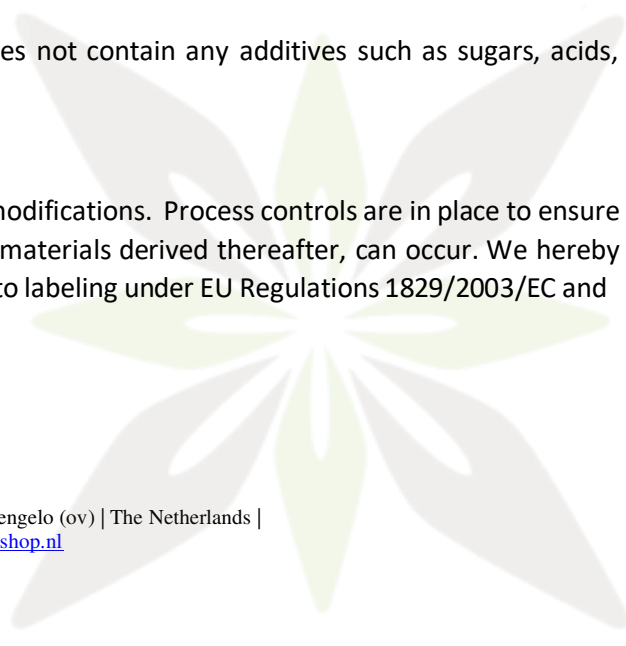
#### AUTHENTICITY

Organic Wheatgrass Powder (New Zealand) is 100% natural and does not contain any additives such as sugars, acids, colorants, preservatives, etc.

#### GMO FREE

Organic Wheatgrass Powder (New Zealand) is not subject to genetic modifications. Process controls are in place to ensure no accidental contamination with genetically modified materials, or materials derived thereafter, can occur. We hereby certify that Organic Wheatgrass Powder (New Zealand) is not subject to labeling under EU Regulations 1829/2003/EC and 1830/2003/EC on genetically modified food and feed.

#### PESTICIDES





Organic Wheatgrass Powder complies with the requirements outlined in Council Regulation (EC) No. 834/2007 (and consecutive amendments). It also complies with Soil Association strict organic farming standards. During the manufacturing process the product and the packaging materials are not exposed to pesticides or pesticide residues. Pesticides are not stored on site, nor used in the manufacturing or warehousing areas.

#### **IRRADIATION**

The product has not been irradiated and complies with the EU regulation 1999/3/EC.

#### **BSE STATEMENT**

Organic Wheatgrass Powder (New Zealand) is produced exclusively from plant source and does not contain any components from animal origin. It has not been derived from any animal source and has not come into contact with any components of animal origin.

#### **RESIDUAL SOLVENTS**

No residual solvents are used in the manufacturing process.

#### **LEVEL OF UNDESIREABLE SUBSTANCES**

The strictly controlled production process of Organic Wheatgrass Powder (New Zealand) ensures that the undesirable substances levels (heavy metals, PAH, mycotoxins, etc.) are below the limits identified by EU legislation (Commission regulation No 2073/2005, No 1881/2006 and consecutive amendments), including the recommendations provided by EFSA on food contaminants.
