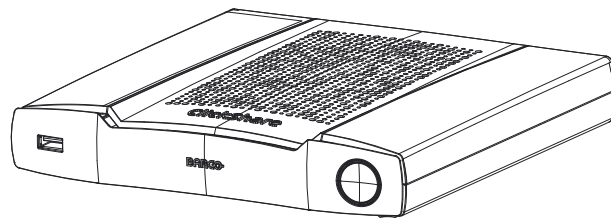

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE OPENING OR DOWNLOADING AND USING THE SOFTWARE.

DO NOT ACCEPT THE LICENSE, AND DO NOT INSTALL, DOWNLOAD, ACCESS, OR OTHERWISE COPY OR USE ALL OR ANY PORTION OF THE SOFTWARE UNLESS YOU CAN AGREE WITH ITS TERMS AS SET OUT IN THIS LICENSE AGREEMENT.

## 1. Entitlement

Barco ClickShare (the “Software”) offered as a wireless presentation solution that includes the respective software components as further detailed in the applicable Documentation.

The Software can be used upon purchase from, and subject to payment of the relating purchase price to, a Barco authorized distributor or reseller of the ClickShare base unit and button or download of the authorized ClickShare applications (each a “Barco ClickShare Product”).

- **Term**

The Software can be used under the terms of this EULA from the date of first use of the Barco ClickShare Product, for as long as you operate such Barco ClickShare Product.

- **Deployment and Use**

The Software shall be used solely in association with a Barco ClickShare Product in accordance with the Documentation issued by Barco for such Product.

## 2. Support

The Software is subject to the warranty conditions outlined in the Barco warranty rider. Maintenance, including the provision of upgrades and updates to the Software, and helpdesk support are available at your option on the terms of Barco’s then current warranty rider.

Higher maintenance and support levels can be obtained at the moment of product sale or during the Barco ClickShare Product and/or Software warranty term.

Higher maintenance and support levels may be included in the initial transaction if ordered and paid for additionally. It is strongly suggested to maintain the maintenance and support agreement without interruption. Barco reserves the right not to restart maintenance following an interruption by the customer.

## 3. Terms of Use

The Software can be used as set out in the Barco EULA attached hereto.

The provisions of this Product Specific EULA override the Barco generic EULA in case of conflicts or inconsistencies.

In case of (inadvertent or other) non-compliance (e.g. where the actual use overshoots the use authorized hereunder), Barco shall have the option to suspend access to the Software until the non-compliance is remedied, failing of which Barco may terminate the License Agreement as set out herein.

## 4. Privacy

You are controller for personal data which are being processed via the Software. Therefore, you remain solely responsible for complying with all applicable data protection laws and for implementing and maintaining privacy protection and security measures (especially for components that you provide or control). Barco disclaims any liability in this regard.

By accepting these terms (through tick box or other mechanism designed to acknowledge agreement to the terms of an electronic copy of this License Agreement), or by installing, downloading, accessing, or otherwise copying or using all or any portion of the Software (as defined below), (i) you accept this License Agreement on behalf of the entity for which you are authorized to act (e.g., your employer) and you agree to act in a manner consistent with this License Agreement (or, if there is no such entity for which you are authorized to act, you accept this License Agreement on behalf of yourself as an individual and acknowledge that you are legally bound by this Agreement), and (ii) you represent and warrant that you are duly empowered by the end user in case you act on behalf of such entity.

If you are unwilling to accept this License Agreement on these terms, or you do not have the right, power and authority to act on behalf of and bind such entity (or yourself as an individual if there is no such entity), DO NOT SELECT THE "I ACCEPT" BUTTON OR OTHERWISE CLICK ON ANY BUTTON OR OTHER MECHANISM DESIGNED TO ACKNOWLEDGE AGREEMENT, AND DO NOT INSTALL, DOWNLOAD, ACCESS, OR OTHERWISE COPY OR USE ALL OR ANY PORTION OF THE SOFTWARE.

### **1. Definitions**

"Affiliate" means any corporation or other entity directly or indirectly, controlling, controlled by or under common control with such corporation or entity.

For the purpose of the above, "control" shall mean (i) the ownership or control, directly or indirectly, of fifty percent (50%) or more of the equity capital or the shares or voting rights in the corporation or other entity in question or (ii) the control of the composition of the board of directors of the corporation or other entity in question.

"Barco" means Barco NV (company number 0473.191.041) with company address at Beneluxpark 21, 8500 Kortrijk, Belgium, or its designated Affiliate licensing to you the proprietary software which is the subject matter of this Agreement.

"Documentation" means all technical, reference and installation manuals, user guides, published performance specifications and other written documentation provided by Barco generally to its licensees with respect to the Software, along with any modifications and updates thereto;

"DRM" means Barco's digital rights management platform used to provide access to and access conditions of the Software.

"License Agreement" means this Barco End User License Agreement (EULA), incorporating the terms of the Product Specific EULA, and any modifications thereof as set out herein.

"Product Specific EULA" means the supplemental software terms applicable

"Software" means the Barco proprietary software which is being licensed hereunder, released in object code only.

"Term" means the period set out in article 9.1 hereof.

"you" means the entity on behalf of which these terms are accepted, and any of its representatives having access to the Software.

### **2. License Grant**

2.1 *'License Scope'*. Subject to compliance with all license terms and payment of applicable fees, Barco grants you a limited, non-exclusive, non-assignable, non-transferable user license (without the right to grant sublicenses). Save for the Product Specific EULA or any broader license terms confirmed through the DRM

tool, (i) the license under this License Agreement applies to one (1) copy of the Software to be used on one single computing device and (ii) installation on a computing device that may be concurrently accessed by more than one user shall not constitute a permitted use and a separate license is required for each active user connected to a computing device on which the Software is being used

2.2 'License Type'. The applicable license type, and your rights in time, deployment and usage, are further detailed in the Product Specific EULA (in the absence of which the scope shall be as set in article 2.1 hereof).

### 2.3 'License restrictions'.

*Intended Use.* You agree to use the Software solely as permitted by this License Agreement (and any Product Specific EULA made part of it) and in a manner consistent with its design and Documentation.

*No Transfer (License Agreement).* You agree not to transfer, assign or sublicense your license rights to any other person or entity, unless Barco's prior written consent is obtained (which consent shall be reasonably given, but may come with a fee).

*No Transfer (Software).* If you deactivate or uninstall the Software from the computer device on which it was originally installed, this will terminate this License Agreement unless otherwise and specifically approved by Barco. You agree not to use the Software in association with other hardware or software that allows to pool connections, reroute information, reduce the number of devices or users that directly access or use the Software, or reduce the number of devices or users the Software directly manages (sometimes referred to as "multiplexing" or "pooling") or otherwise attempt to reduce the number of licenses of any type that you need.

*Authorized Users.* The use of the Software is restricted to persons within your organization, or any third party representatives operating under your responsibility and control, provided any such persons have accepted the terms of this License Agreement. You agree not to use or permit the Software to be used to perform services for third parties, whether on a service bureau or time sharing basis or otherwise, without the prior written authorization of Barco. You shall not lease, rent, or otherwise transfer or grant a security or other interest in the Software.

*No Modifications.* You shall not make error corrections to or otherwise modify or adapt the Software or create derivative works based upon the Software, or permit third parties to do the same.

*No Reverse Engineering.* You agree not to reverse engineer or decompile, decrypt, disassemble or otherwise reduce the Software to human-readable form, except to the extent otherwise expressly permitted under applicable law notwithstanding this restriction, or except to the extent Barco is legally required to permit such specific activity pursuant to any applicable open source license.

*Code required to ensure interoperability.* To the extent required by law, and at your written request, Barco shall provide you with the interface information needed to achieve interoperability between the Software and another independently created program used by you, on payment of Barco's applicable fee (if any). You shall observe strict obligations of confidentiality with respect to such information and shall use such information in compliance with terms and conditions which Barco makes applicable.

*No Unbundling.* The Software may include various applications and components, may support multiple platforms and languages, and may be provided on multiple media or in multiple copies. Nonetheless, the Software is designed and provided to you as a single product to be used as a single product on devices as permitted herein. You agree not to unbundle the component parts of the Software for use on different computer devices.

*Territory.* You agree to use the Software solely in the territory or region where you obtained the Software from Barco or its authorized reseller or as otherwise stated in the Documentation. Any export if permitted shall comply with any applicable (export) laws and regulations.

2.4 'Your Infrastructure'. You remain responsible to procure and maintain hardware, operating system, network and other infrastructure (the "Infrastructure") required to operate the Software and to keep such Infrastructure functioning and virus-free. You acknowledge that the Software is a complex computer software application, and that the performance thereof may vary depending hardware platform, software interactions and configuration. You acknowledge that the Software is not designed and produced specifically to meet your specific requirements and expectations and the selection of the Software by you is entirely your own choice and decision.

## 3. Ownership. Intellectual Property Rights.

3.1 'Ownership'. Any Software is licensed, not sold to you, on a non-exclusive basis for use only under the terms of this License Agreement, and Barco and its suppliers reserve all rights not expressly granted to you. You may own the carrier on which the Software is provided, but the Software is owned and copyrighted by Barco or by third party suppliers. Your license confers no title or ownership and is not a sale of any rights in the Software or its Documentation.

3.2 *'Third Party Materials'*. The Software may contain or require the use of certain third party technology (whether proprietary or open source software), identified by Barco in the Documentation, readme file, third-party click-accept, on [www.barco.com](http://www.barco.com) or elsewhere (the "Identified Components"). Identified Components may be subject to additional and/ or different terms and you agree that the Identified Components are licensed under the terms, disclaimers and warranties of their respective licenses which in the forthcoming case shall override the provisions of this License Agreement.

3.3 *'Source Code Access'*. To the extent required under third party (open source) license terms, and for a period of 36 months following your acceptance of this License Agreement, Barco shall provide access to the source code controlled by a third party (open source) license, via email or download link. If the relevant license terms require so, you may require Barco (attn. its legal department, at the address stated above) to obtain such code on tangible medium against payment of the cost of media, shipping and handling.

3.4 *'Copyright'*. The Software is protected by national and international laws and treaty provisions. Copyright on the Software components belongs to the respective initial copyright holder, each additional contributor and/ or their respective assignee(s), as may be identified in the Software Documentation, source code, README file, or otherwise. You shall not remove or obscure or otherwise alter the respective copyrights.

3.5 **Trademarks**. Brand and product names mentioned in relation to the Software may be trademarks, registered trademarks or copyrights of their respective (third party) holders. All such brand and product names mentioned in relation to the Software serve as comments or examples and are not to be understood as advertising for the products or their manufacturers.

3.6 *'Trade Secrets'*. You agree not to disclose, provide or otherwise make available trade secrets contained within the Software and Documentation in any form to any third party without the prior written consent of Barco. You shall implement reasonable security measures to protect such trade secrets.

#### **4. Support**

4.1 *'Principle'*. Barco is under no obligation to provide support in respect of the Software, except as included in a Product Specific EULA and/or the extent you have entered into a separate maintenance agreement. Any unauthorized use of the Software may prohibit Barco from providing such support.

4.2 *'Support policy'*. Barco may provide to you maintenance releases to address bugs or security issues in the Software and you agree to install the same. Any other updates or upgrades can be obtained under the terms of a separate software maintenance which is being offered to you. You may have a right to downgrade your licensed Software application to (only) such earlier version of the same Software application as agreed by Barco in the forthcoming case.

Additional functionality may be licensed to you with and subject to additional or different terms.

#### **5. Warranty**

EXCEPT FOR THE LIMITED WARRANTY THAT MAY APPLY AS PER THE PRODUCT SPECIFIC EULA, YOU UNDERSTAND THAT THE SOFTWARE IS BEING PROVIDED TO YOU "AS IS". BARCO DOES NOT MAKE NOR INTENDS TO MAKE ANY WARRANTIES OR REPRESENTATIONS, EXPRESS OR IMPLIED AND SPECIFICALLY DISCLAIMS ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT OF INTELLECTUAL PROPERTY AND DOES NOT WARRANT THAT THE SOFTWARE WILL BE FREE FROM ERRORS OR THAT YOU WILL BE ABLE TO OPERATE THE SOFTWARE WITHOUT INTERRUPTIONS OR THAT SUCH ERRORS WILL BE CORRECTED BY BARCO. EXCEPT FOR ANY MAINTENANCE AND SUPPORT OBLIGATIONS SEPARATELY AGREED, YOU ARE SOLELY RESPONSIBLE FOR ALL COSTS AND EXPENSES ASSOCIATED WITH RECTIFICATION, REPAIR OR DAMAGE CAUSED BY SUCH ERRORS. IN THE FORTHCOMING CASE, THE WARRANTY DISCLAIMER FOUND IN APPLICABLE OPEN SOURCE LICENSES SHALL OVERRIDE THE PROVISIONS OF THIS LICENSE AGREEMENT.

#### **6. Compliance and Enforcement**

6.1 *'Reporting and Audit'*. In addition to good practice record-keeping obligations, you agree to report the use of the Software and relating billing metrics in the DRM or otherwise as agreed. You grant to Barco and its designated auditors, at Barco's expenses, the right to verify your Software deployments and to examine your books, records and accounts during your normal business hours so as to verify your compliance with the License Agreement. In the event such audit discloses non-compliance with your payment obligations hereunder, you shall promptly pay to Barco the appropriate license fees plus the reasonable cost of conducting the audit.

6.2 *'Enforcement'*. Barco shall notify the then known user through the DRM (failing of which, otherwise in writing) of a substantial non-compliance, based on the triggers as per the Product Specific EULA. The non-compliance may result in an immediate or graduate denial of service (i. e. termination of the rights granted

under the License Agreement), in part or in full, all based on the level of severity of the non-compliance [as per the Product Specific EULA].

6.3 *'Indemnification'*. YOU HEREBY AGREE TO INDEMNIFY, DEFEND AND HOLD HARMLESS BARCO AND BARCO'S AFFILIATES FROM AND AGAINST ANY AND ALL ACTIONS, PROCEEDINGS, LIABILITY, LOSS, DAMAGES, FEES AND COSTS (INCLUDING ATTORNEY FEES), AND OTHER EXPENSES INCURRED OR SUFFERED BY BARCO ARISING OUT OF OR IN CONNECTION WITH ANY BREACH BY YOU OF THE TERMS OF THIS SOFTWARE LICENSE.

## **7. Limitation of Liability**

TO THE MAXIMUM EXTENT PERMITTED BY LAW, BARCO ACCEPTS NO LIABILITY FOR ANY DAMAGES, LOSSES OR CLAIMS YOU OR ANY THIRD PARTY MAY SUFFER AS A RESULT OF YOUR USE OF THE SOFTWARE. IN JURISDICTIONS WHERE BARCO'S LIABILITY CANNOT BE EXCLUDED, BARCO'S LIABILITY FOR DIRECT DAMAGES SHALL BE LIMITED TO AN AMOUNT OF 250 EURO IN THE AGREGATE (OR TO THE MAXIMUM EXTENT PERMITTED BY LAW WHERE NO FURTHER EXCLUSION IS LEGALLY ALLOWED).

TO THE MAXIMUM EXTENT PERMITTED BY LAW, IN NO EVENT WILL BARCO BE LIABLE FOR ANY INDIRECT, SPECIAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL LOSS OR DAMAGES OF ANY KIND WHICH MAY ARISE OUT OF OR IN CONNECTION WITH THE SOFTWARE, THIS SOFTWARE LICENSE OR THE PERFORMANCE OR PURPORTED PERFORMANCE OF OR FAILURE IN THE PERFORMANCE OF BARCO'S OBLIGATIONS UNDER THIS SOFTWARE LICENSE OR FOR ANY ECONOMIC LOSS, LOSS OF BUSINESS, CONTRACTS, DATA, GOODWILL, PROFITS, TURNOVER, REVENUE, REPUTATION OR ANY LOSS ARISING FROM WORK STOPPAGE, COMPUTER FAILURE OR MALFUNCTION OF THE SOFTWARE AND ANY AND ALL OTHER COMMERCIAL DAMAGES OR LOSSES WHICH MAY ARISE IN RESPECT OF USE OF THE SOFTWARE, EVEN IF BARCO HAS BEEN ADVISED OF THE POSSIBILITY OF THEIR OCCURRENCE.

## **8. Confidentiality**

8.1 *'Confidential Information'*. You will be receiving information which is proprietary and confidential to Barco during the negotiation and Term of this License Agreement. "Confidential Information" shall include (i) the underlying logic, source code and concepts of the Software or other trade secrets (the access to which is strictly limited as expressly set out herein), (ii) any information designated as confidential by Barco or which has the necessary quality of confidence about it and (iii) any license key provided by Barco to you hereunder.

8.2 *'Non-Disclosure'*. You agree not to divulge any Confidential Information to any persons without Barco's prior written consent provided that this article 8 shall not extend to information which was rightfully in your possession prior to the commencement of the negotiations leading to this License Agreement, which is already public knowledge or becomes so at a future date (otherwise than as a result of a breach of this article 8), to the extent it is required to be disclosed by law or which is trivial or obvious. You agree not to use any Confidential Information except for the authorized purpose hereunder. The foregoing obligations as to confidentiality shall survive the Term of this License Agreement.

## **9. Term and Termination**

9.1 *'Term'*. The duration of this License Agreement will be from the date of your acceptance (as set forth above) of the Software (whereby you acknowledge that use of the Software implies acceptance), until you deactivate the Software, discontinue the use of the device on which the Software was first installed for its intended use or the expiration of the limited time period set out in the Product Specific EULA, whichever comes first.

9.2 *'Termination'*. You may terminate this License Agreement at any time by destroying all copies of the Software then in your possession and returning all Documentation and associated materials, to Barco or the appointed Barco reseller that sold or provided these to you. Barco may terminate this License Agreement, immediately or gradually in accordance with article 6 hereof, by informing you at any time if any user is in breach of any of the License Agreement's terms.

9.3 *'Consequences of Termination'*. All rights associated with the use of the Software and the acquisition of updates and upgrades cease once the contract is terminated or expires. Cancelling your license will stop recurring fees going forward, but will not retroactively refund current or past payments.

## **10. Other relevant terms**

10.1 *'Data Protection'*. Barco may, without restriction, save, process, use and reuse any data obtained in connection with the sales or supply of the Services. Barco shall take suitable technical and organizational measures to protect personal data received against loss and unlawful processing.



10.2 *'Functional Information'*. Via the Software, Barco may gather technical, aggregated and/or statistical information about (i) the functioning and the functionality of the products which are connected through the Software, and/or (ii) as provided by You or generated by Your use of the Software ("Functional Information"). Barco and its service providers may process and use such Functional Information for analytics purposes, for developing and improving products and services, offering products and services to Your organization, all based on the legitimate interest of Barco of evaluating the market, assessing and improving its products and conducting research and development. This Section shall survive the term of this Agreement.

10.3 **Return of Data**. Upon Your request made within 60 days after the termination or expiration of this Agreement, Barco will make User Data available to You for export or download as provided in the Documentation. After such 60-day period, Barco shall have no obligation to maintain or provide any User Data, and as provided in the Documentation will thereafter delete or destroy all copies of User Data in Barco's systems or otherwise in Barco's possession or control, unless legally prohibited.

## 11. Final Clauses

11.1 *'Entire Agreement'*. This License Agreement is the only understanding and agreement between you and Barco for use of the Software. This License Agreement supersedes all other communications, understandings or agreements we had prior to this License Agreement (with the exception of any continuing confidentiality agreement).

11.2 *'Notices'*. Notices can be validly delivered to the parties' last known address.

11.3 *'Severability'*. This License Agreement shall not be altered, amended or varied. If any provision of this License Agreement is determined to be illegal, void or unenforceable, or if any court of competent jurisdiction in any final decision so determines, this License Agreement shall continue in full force save that such provision shall be deemed to be deleted with effect from the date of such decision, or such earlier date, and shall be replaced by a provision which is acceptable by law and which embodies the intention of this License Agreement as close as possible.

11.4 *'Export'*. You acknowledge that this Software may be subject to U. S. or other governments Export Jurisdiction. You agree to comply with all applicable international and national laws that apply to the Software, including the U. S. Export Administration Regulations, as well as end-user, end-use, and destination restrictions issued by the U.S. or other governments.

## 2.1 About the CX-50

### CX-50 sets

With the Conferencing Button, in seconds, you are automatically connected to cameras, mics, soundbars and any other AV peripherals in the room for a better, more immersive meeting experience. Everything becomes part of your laptop.

This CX-50 not only helps the presenter get the presentation on-screen in a second, but it also allows the other people in the conference to participate more actively. The result is enhanced meeting efficiency and better decision-making.

The set is compatible with any laptop, desktop tablet or smartphone OS. It works with most conferencing platforms and connects instantly with most brands of peripherals (speakers, microphones, webcams, soundbars) when using the Conferencing Button.

At the moment 6 different sets are available on the market. Each set is sold in its specific region and it can only be used in that specific region because of WiFi regulations.

### Components CX-50 set

A standard CX-50 set consists of a Base Unit and 2 Conference Buttons. Depending on the location where you buy the product, the software of the Base Unit is different. If needed, you can buy additional Conferencing Buttons and a tray to store the Buttons.

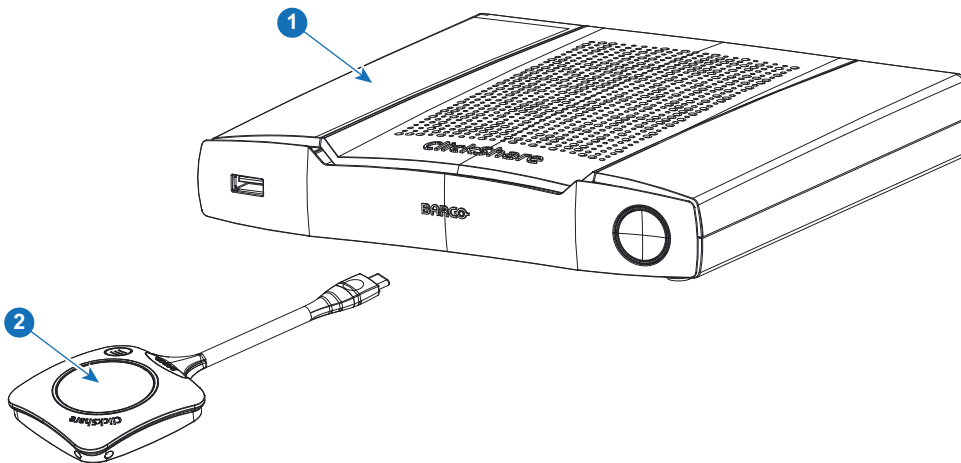

## 2.2 About the Base Unit

### Base Unit functionality

The Base Unit receives the wireless input from the Buttons and controls the content of the meeting room display and the peripherals connected to the Base Unit (speakers, microphones, webcam and soundbar). Furthermore, it will send out the content from the camera and/or the speakerphone towards the Button.

The Base Unit can be inside a cabinet in the meeting room, or put on the meeting room table or mounted on a wall. Check the Installation Guide for instructions on how to install the Base Unit.

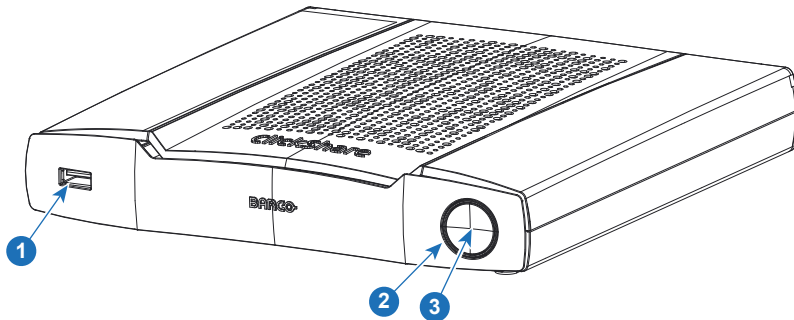

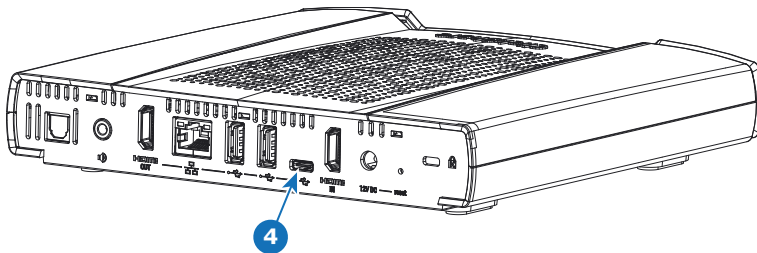

### USB Type-A Port

The USB port is used to update the software of both the Base Unit and the Buttons and to connect a touch screen, USB camera or USB echo-cancelling speakerphone to the Base Unit.

### USB Type-C™ Port

The USB Type-C™ port is used to pair the Button to the Base Unit. This port can also be used to update the software of both the Base Unit and the Buttons and to connect a touch screen, USB camera or USB echo-cancelling speakerphone to the Base Unit.

When plugging in the Button into the Base Unit, the Button is paired to the Base Unit. The Base Unit checks whether the software and firmware of the Button is up to date. If not, the Base Unit updates the software and/or firmware.

### Status LED ring

The color of the LED ring around the power button of the Base Unit give information on the status of the system.

## Power button

The button at the front of the Base Unit has a standby function once the Base Unit is powered.

- When the system is in normal operational mode, a push makes the system go into a pre-defined standby mode.
- When the system is in standby, a push triggers the system to start up and it goes into normal operational mode.

## 2.3 About the Button

### Button layout

A Button consists of five main components

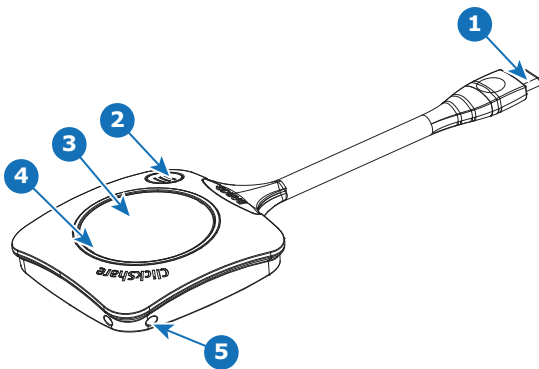

## USB connector

Using the USB connector the Button can be plugged into a laptop (for sharing your screen) or the Base Unit (for pairing the Button to the Base Unit or updating its software). Button R9861600D1C has a USB Type-C™ connector. Depending on the type of USB port on your laptop or on the Base Unit a convertor must be used.

## Button

By inserting the Button, the peripherals attached to the Base Unit can be used in the tool of your preference. Click the Button to display the content of the laptop's screen on the meeting room display. Clicking the Button during the meeting will toggle the sharing of the screen. Click the small button to get additional functionality and controls.

## LED ring

The LED ring indicates the current status of your ClickShare.

5. While sharing content, the laptop will not go to standby. Once sharing is stopped, the laptop will again be capable of going to standby.

## 3.1 Activating the Base Unit

### About power mode

The Base Unit is powered via an external power adapter. Once connected, the Base Unit is automatically switched in standby mode. For more information about power connection, see CX-50's installation manual.

### Standby button

1. Push the button shortly.

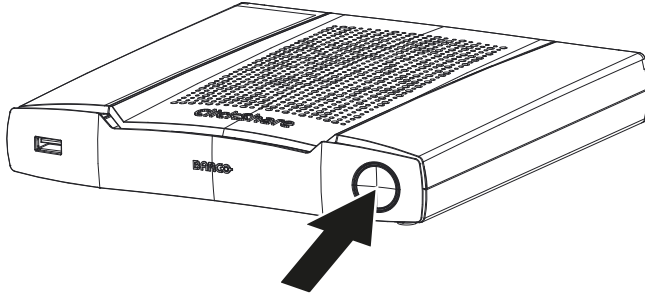


Image 3-1 Standby button

When the Base Unit was on, it goes to standby.

When the Base Unit was in standby, it starts up.

## 3.2 Basic Use, with Button

### Basic functionality

When entering a meeting room equipped with ClickShare and if the display is not in screensaver mode, the ClickShare wallpaper is shown on the display. The content of the wallpaper depends on the setup. Connected peripherals to the Base Unit and their status are indicated on the wallpaper.

Starting to use ClickShare is now very simple.

### To start using CX-50 with a Button

1. Take a Button and insert the Button into a USB port of your laptop. Depending on the USB port on your laptop a convertor must be used. This convertor is not delivered by Barco.

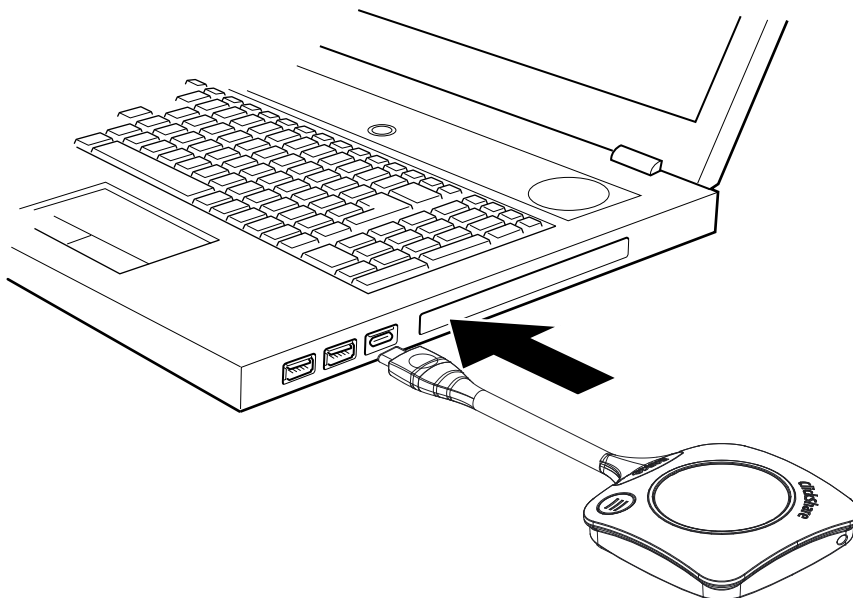

In the meanwhile

The white ring on the Button is filling up. When totally filled up it goes to static white and is ready to share or it starts blinking to indicate that you have to start clickshare.exe on your computer.

On your laptop a new drive appears.

Different situations are possible now:

- Nothing installed, LED ring fills up and starts flashing, indicating that the executable needs to be started by the user. Double-click the ClickShare application.
- For Windows environment: when connected to internet, driver will be installed and the executable will be started by the driver.
- For Mac environment: CD-ROM drive will appear, open it and launch the application to get started.
- A launcher or the ClickShare desktop app is preinstalled on your laptop (downloaded from the Base Unit or Barco website, or deployed company-wide by your IT department). ClickShare is immediately available.

In the meanwhile a *Preparing the meeting room...* window is displayed.

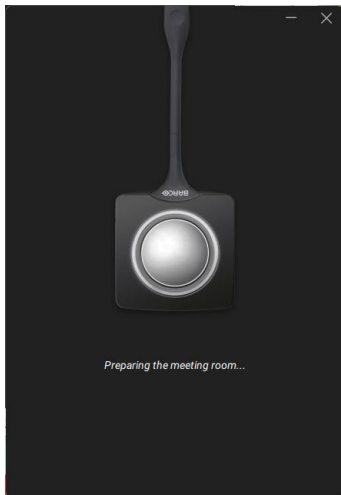

## 2. The application is started

When the system is ready for use, the share window appears with the message Ready to share to <ClickShare name>

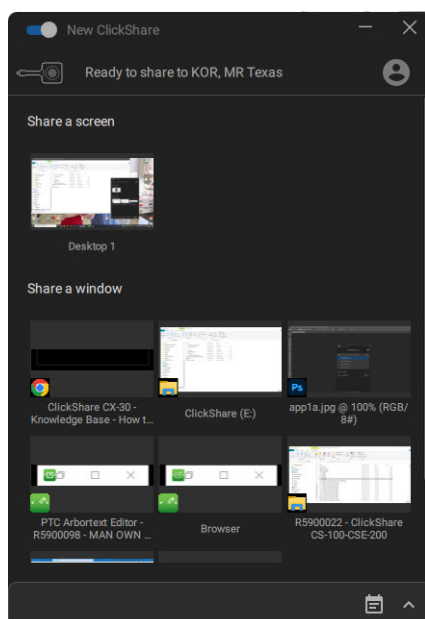

## Getting started

The peripherals such as USB camera, echo cancelling audio device, etc. can now be used in the tool of your preference on your device.

Your screen or a typical application can be shared.

3. There are now 2 ways to start sharing:
  - by clicking on the Button.
  - by clicking on your screen or application in the app window.

When clicking on the Button, the LEDs of the Button become static red and your display is shared.

When selecting in the app, your choice will be shared.

When audio is enabled on the ClickShare Base Unit, the audio of your laptop is also available on the audio output of the Base Unit, and it will be played via the meeting room audio system.

When a USB echo cancelling audio device is connected to the Base Unit, all audio, content audio and speaker audio is played via the speakerphone system.

A pause and stop sharing indication is made in the app window and the window will be minimized.

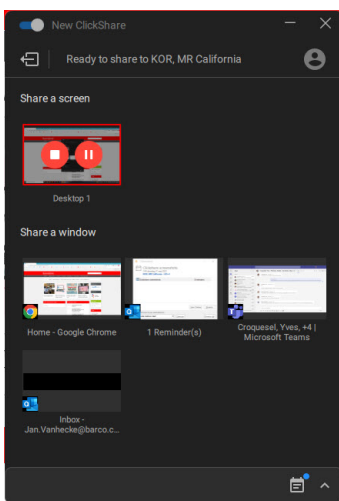

ClickShare automatically scales the content of your screen/application to the resolution of the meeting room display. The aspect ratio of your screen is maintained to make sure the proportions are correct.

4. To freeze the content on the screen while you look up something on your PC, just click on freeze icon (reference 1) in the shared window. The icon will change to a release icon.

To resume the content sharing, click on that release icon.

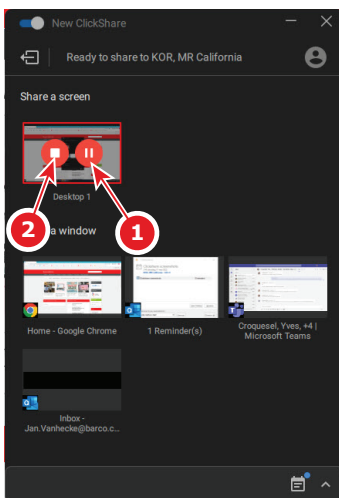

5. To remove your content from the display, click the Button again or click on the stop sharing icon (reference 2 on [Image 3-6](#)) in the app window.

The LEDs of the Button become static white.

- When leaving the meeting room, unplug the Button from your laptop or click on the exit icon on the upper left corner.

When there was no installation when starting with the Button, no trace of the ClickShare application is left on your laptop.



As second user can replace the current presenter with a long press on his Button.

## Use in a fully equipped conference room

When connecting with the Button, it allows you to connect the room speakerphone, microphone and camera wireless to your laptop and use the better equipment of the room in your video conferencing call.

Icons on the wallpaper indicate the availability and status of the peripherals in the room. When one of them is not attached to the Base Unit allowing to create an audio only meeting room or a video only meeting room, the corresponding icon will not be shown on the wallpaper.

The state of the peripheral icons on the wallpaper are in sync with the peripherals.

When the microphone is muted, it is guaranteed that no sound is going through the system. A muted microphone is indicated by a microphone icon with dash through the icon.

## Available conferencing capabilities when Button plugged in

### When not sharing content

Camera and speakerphone can be used from the moment the Button is inserted and initialized. The person hosting the call does not need to be on screen for this to work (he does not even need to start the ClickShare application). This is useful especially when others are sharing in the room and the host shares the room display via local view or when you use the peripherals for e.g recording.

### When sharing content (big button pressed)

Only when the big Button is pressed, the screensharing is started. Screen content and content audio are transmitted to the main display. When the user stops sharing, you return to the *Button inserted* state. Call continues without interruption.

### Button used in a conference room

When plugging in the button, a quick start guide for conferencing capabilities is shown. It shows what should happen before you can fully use the conference capabilities.

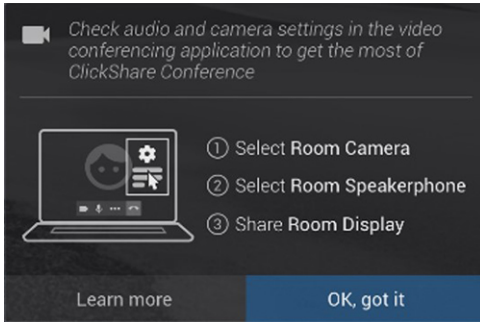

This quick access button opens a selection window to make the choice what will be displayed on the screen.

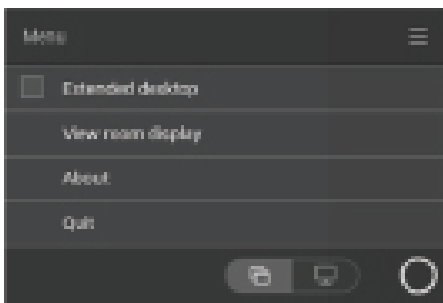

## 3.3 Basic Use, with ClickShare desktop app

### About the ClickShare desktop app

With the ClickShare desktop app installed on your computer you can enter a meeting room and get on the screen in a few seconds.

The ClickShare desktop app connects to the meeting room screen in order to share your content. Presence detection technology is used to do so. The ClickShare desktop app uses Wi-Fi beacons and an inaudible audio signal to detect the most nearby meeting rooms and show a list of maximum 5 most nearby meeting rooms, sorted based on signal strength on your computer. Just click on your meeting room name. This means you will never have to enter IP addresses or scroll long lists of meeting rooms before being connected to your meeting room.

The ClickShare desktop app can be used with or without a Button.

### ClickShare desktop app installation

When the ClickShare desktop app is not pre-deployed in your IT environment, you can download and install the software without administrator rights from [www.clickshare.app](http://www.clickshare.app).

## How to use

### 1. Enter a meeting room.

The ClickShare desktop app will list up to 5 most nearby meeting rooms and sort them based on the signal strength.

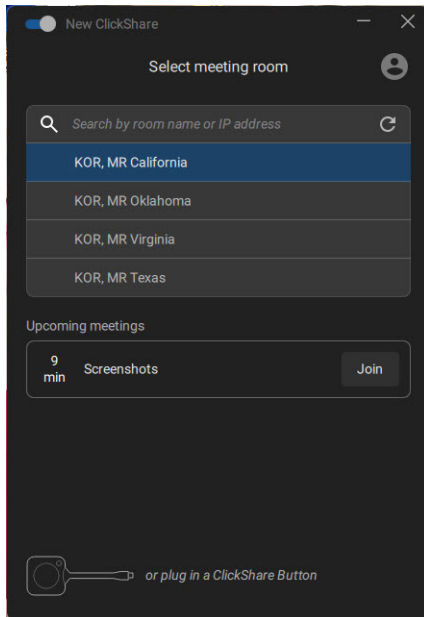


Image 3–10 Meeting room list

### 2. Click on the desired meeting room.

If the use of a pin is enabled on the Base Unit, the ClickShare desktop app will prompt you to enter the pin that is shown on the meeting room screen. An indication where to find the pin code on the screen is given in the desktop app and indicated with a red arrow.

Enabling the pin on the Base Unit (this can be done in the ClickShare Configurator) provides an additional layer of security. This way you will never share your content to the wrong meeting room screen.

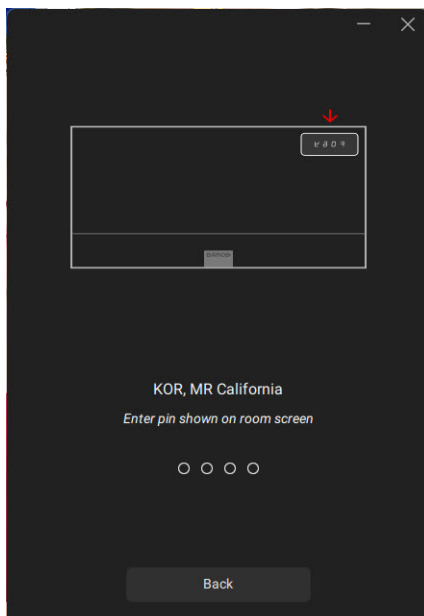


Image 3–11 Enter pin

After having entered the pin, the ClickShare desktop app will connect to the meeting room.

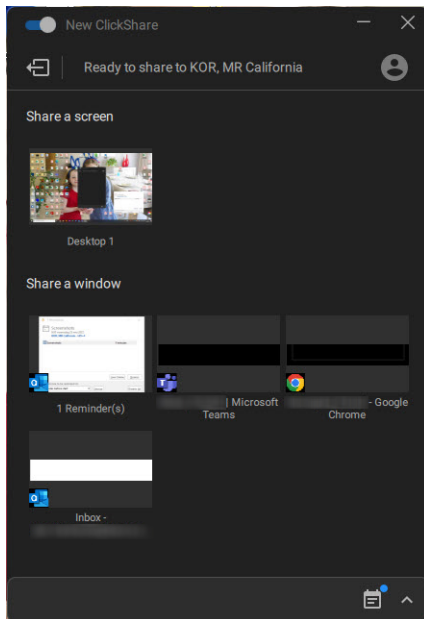


Image 3–12 Ready to share

3. Start sharing a display or a window. Click on the desired object you want to share.

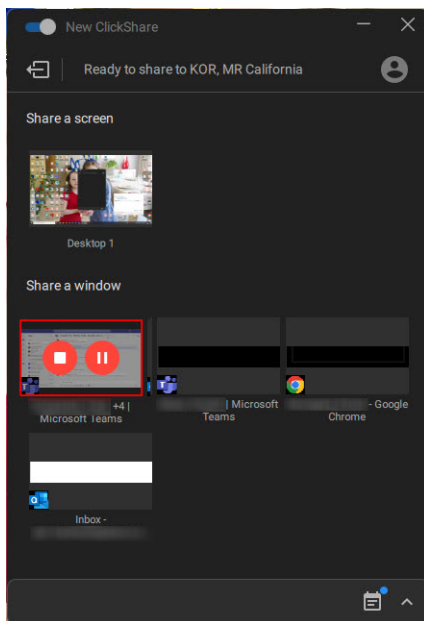

When the sharing is started, a stop sharing and pause icon is added on the shared window and the ClickShare desktop app will minimize after a while.

Click on the minimized icon to open the full interface of the ClickShare app.to

- either pause your sharing session (freeze the content) on the screen while you work on your laptop (invisible for people in the meeting room). Click on the pause icon (reference 1).
- stop sharing. Click on the stop sharing icon (reference 2).

4. Disconnect from the meeting room by clicking the “leave room” icon on the upper left corner.

or

when you walk away from the meeting room the app will show a message indicating you probably left the meeting room and you are still connected to the screen.

## ClickShare Desktop app in a conference room

With just one click in the ClickShare App you join the next virtual meeting on your agenda. Your Outlook calendar automatically synchronizes with the ClickShare Collaboration App. The next Microsoft Teams meeting on your agenda is shown in the ClickShare App: join that call with just one click, your Teams App will open automatically and your call will start immediately. The same is true for your Zoom, Webex or other calls as well.

One click to share your content. Start sharing content in a Microsoft Teams, Zoom or Webex call and ClickShare automatically shares the same content to the meeting room display.

## Joining a conference

When using Outlook for creating appointments or invites, you will get an immediate overview in the ClickShare Desktop app of your next meetings.

Just click to join your next call whether in Teams, Zoom or WebEx. The appropriate application will open automatically.

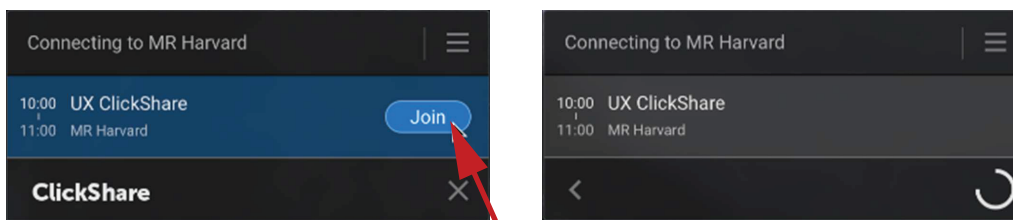

## 3.4 ClickShare Desktop App Calendar

### About calendar

Once the ClickShare Desktop App is installed, it will show you the upcoming and ongoing meetings you can join, based on your personal calendar. Depending on the type of meeting and its location information, you'll be able to connect to the meeting room and/or join the conference call linked to the meeting with one click.

By default, the One-Click Join experience is enabled and the ClickShare Desktop App connects to the Microsoft Outlook client running on your computer to retrieve the relevant meeting information. It does this within the active Windows session and only displays limited meeting information in the App. No meeting information is stored on your computer or processed anywhere else.

### Enabling or disabling the integration

1. Open the ClickShare Desktop App.
2. Click on the menu icon on the right top to open the menu.

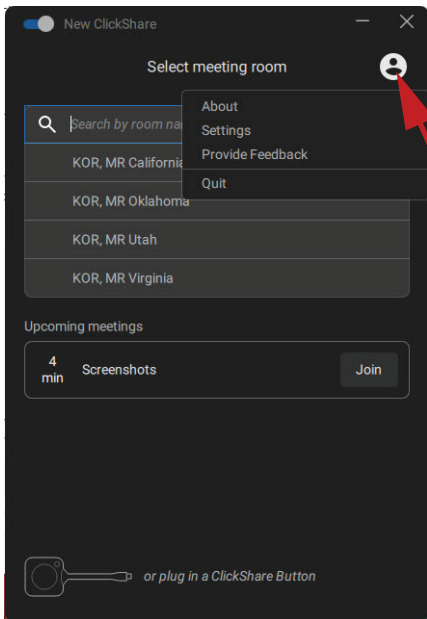

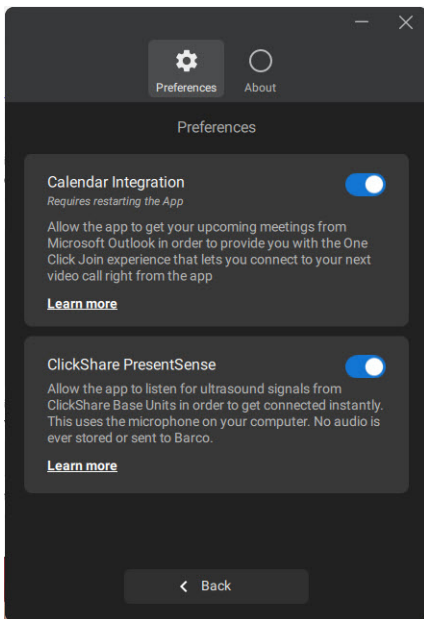

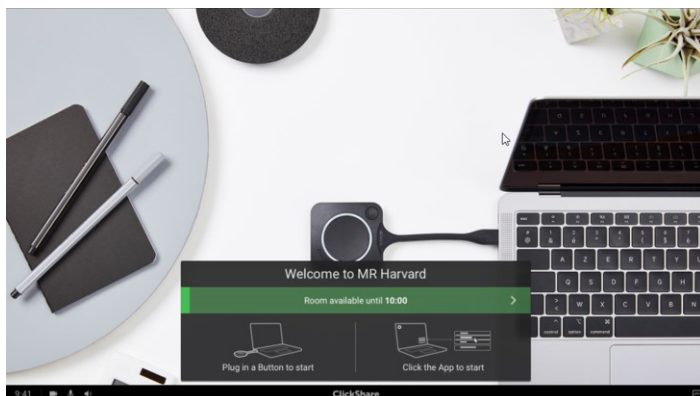

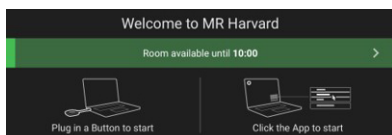

## 3.6 Walk in and connect with ClickShare PresentSense™

### Introduction

PresentSense makes seamless connection to the room's Base Unit possible as soon as you walk into the room. The ClickShare desktop app on your PC detects the Base Unit in the room and asks you to click Connect to connect to the room's Base Unit. There is no longer need to search through a list of nearby meeting rooms.



ClickShare PresentSense requires version 4.5 or higher of the ClickShare desktop app to be installed on your computer.

This function is only available for Windows™.

### How it works

The ClickShare Base Unit in the meeting room sends out an ultrasound signal, that is picked up by the ClickShare Desktop App through your devices' microphone. Because of the characteristics of sound, that signal will only be available within the meeting room, ensuring you're in the room when the App picks up the signal.

Because ClickShare PresentSense uses your devices' microphone to detect the ultrasound signal you will need to allow the ClickShare Desktop App to use the microphone before it can start detecting the PresentSense signal.

### How to allow the use of your microphone

1. Open your ClickShare Desktop App and click on the menu item.

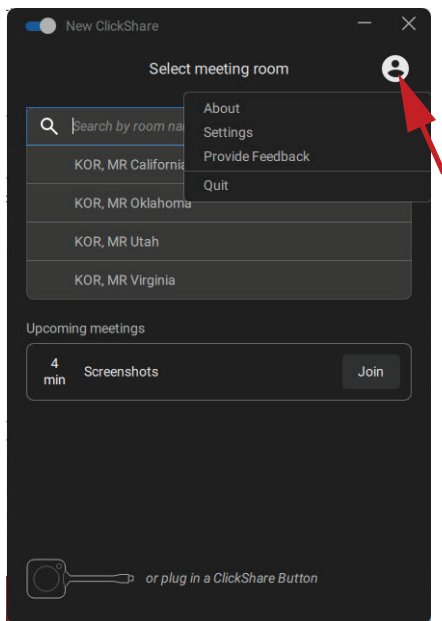

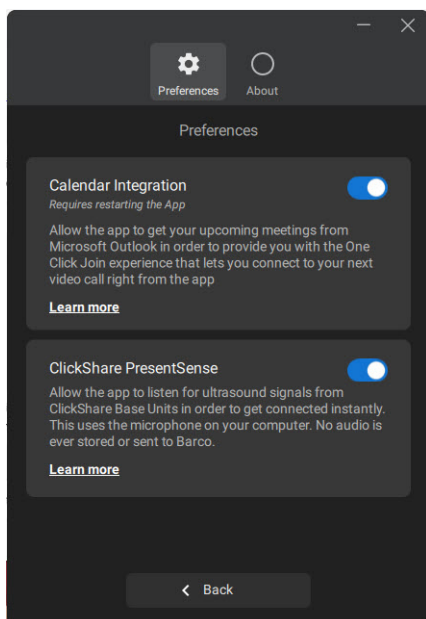

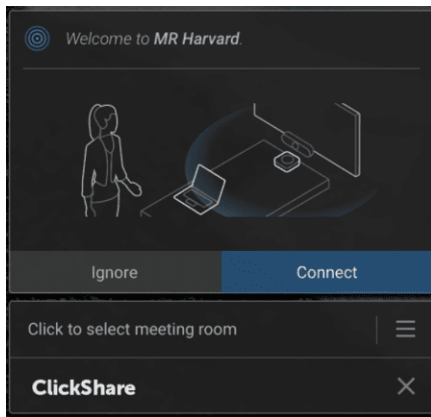

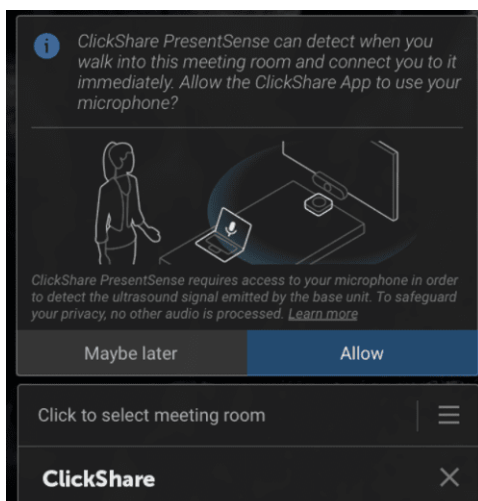

### About app based conferencing

App-based Conferencing enables you to use the meeting room camera and speakerphone as soon as you're connected to the room with the ClickShare Desktop App.

With this, the ClickShare Desktop App enables you to join your Zoom, WebEx, or Microsoft Teams calls in a single click, and to use the room camera and speakerphone in that call without needing to plug in a Button.



App-based Conferencing requires version 4.15 or higher of the ClickShare Desktop App, installed through the MSI installer, with the App-based Conferencing feature enabled. Installation can only be done with administrator rights on your computer. Contact your IT administrator to install or deploy it for you.

### How it works

1. Click on the ClickShare icon to open the ClickShare Desktop App

Select the meeting room out of the displayed list of nearby meeting rooms.

Connect to the meeting room.

or

when the PresentSense function is active in that meeting room and on your PC, just walk in and click **Connect** to get started.

As soon as you are connected to the room, the meeting room peripherals (camera, microphone, and speaker) become available on your computer and are ready to use in your video call.

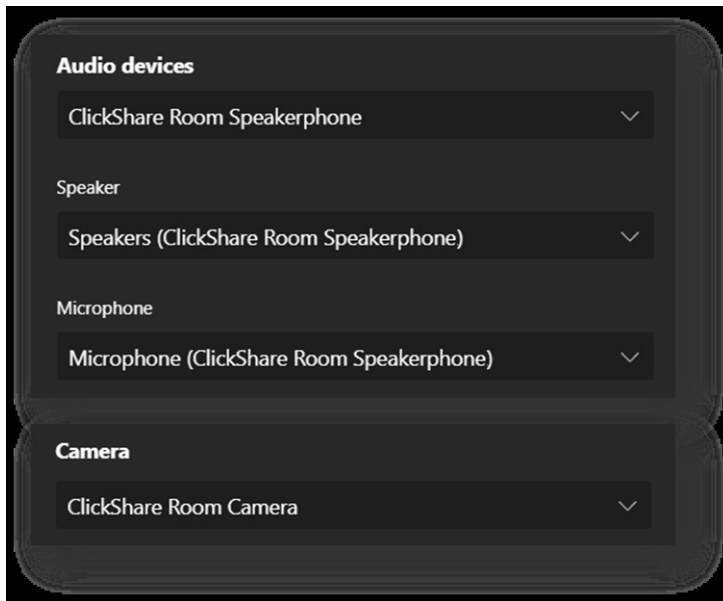

2. At the end of the meeting, simply disconnect from the meeting room or walk out and the devices will disappear from your computer.

## 3.8 User Interface

### User Interface functionality

When a Button is plugged in or the ClickShare desktop app is running and ready for sharing (not sharing yet), additional functionality (context menu) can be selected via the hamburger menu icon.

## Context menu

1. Click on the menu icon on the Ready to share message.

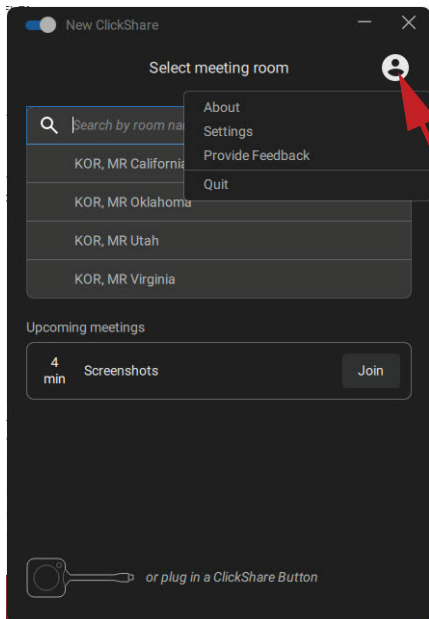

## 3.9 Extended desktop

### About extended desktop

Depending on your selection, your primary screen or your extended screen will be captured and displayed via ClickShare. That extended screen can be a physical screen or a virtual screen.

The use of the extended desktop functionality does require the extension pack to be installed on your device. More information on the extension pack can be found on the ClickShare Extension pack product page (<https://www.barco.com/en/product/clickshare-extension-pack>).

With extended desktop you can take advantage of both your laptop screen and the central meeting room display. Presentation notes or other material on primary screen will not be displayed to everyone (so-called PowerPoint Presenter mode) or when you want to take notes whilst sharing something else..

Note that the Presenter mode can also be achieved without the use of the extended desktop and one can also choose to share only the application you wish to share in the room via the sharing mode toggle (see “Share an application”, page 38).

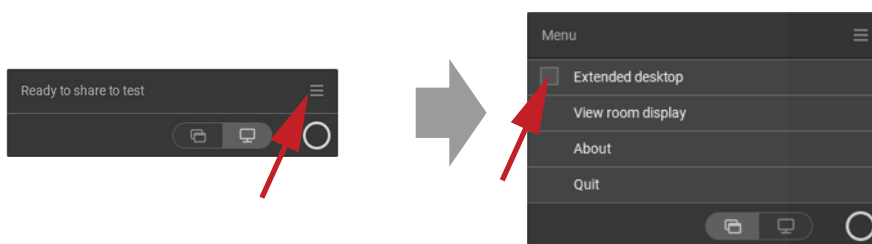

## 3.10 Share an application

### About sharing an application

When *Share an application* is selected, you will be presented with an overview of open applications on your computer. Once you select an application to share, only this application will be shared on the big screen

## How to select via the application window

1. When a Button is plugged in or the ClickShare desktop app is ready to share..

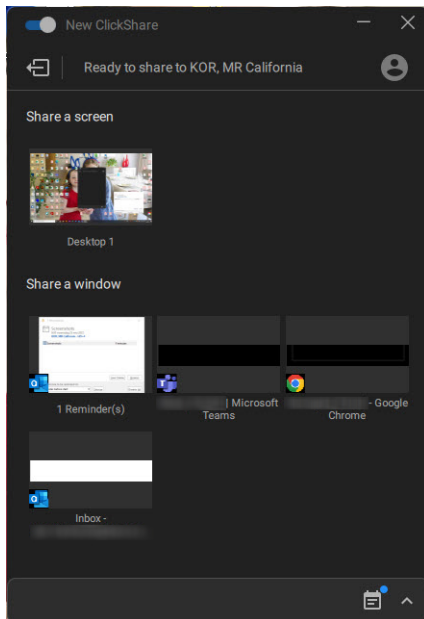


Image 3–31 Ready to share

The last 6 open applications on your computer are displayed.

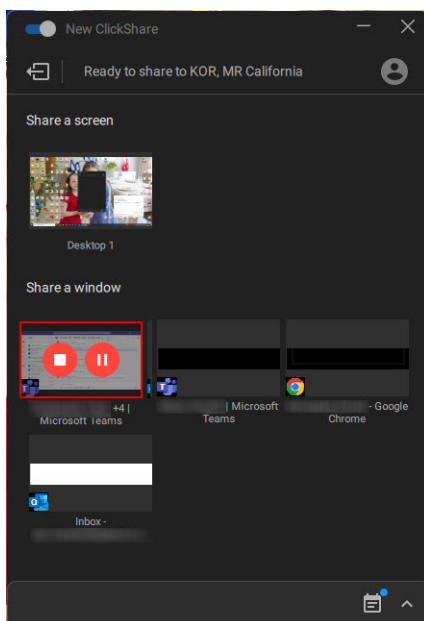

1. Push the quick access button and click on the *share an application* icon.

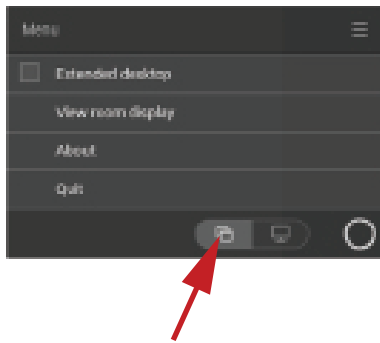

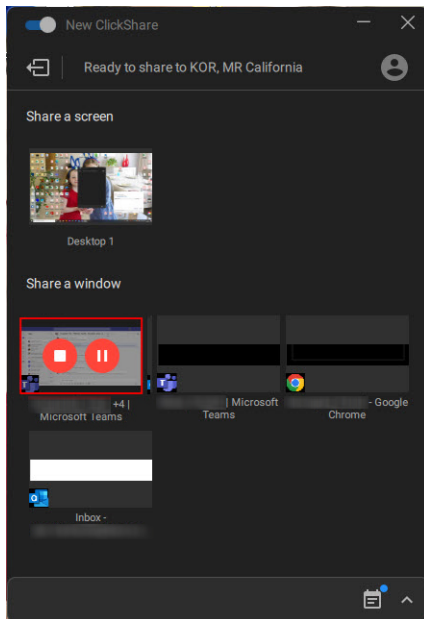

## 3.11 Microsoft Office PowerPoint Presenter mode

### Overview

To view your speaker notes on your pc when sharing a presentation on the room display, one can make use of the PowerPoint Presenter mode functionality in Microsoft Office PowerPoint without the need for a second (virtual) display.

When sharing a Slide Show using Share an application you will be reminded of the Presenter Mode functionality through a useful notification. This notification remains on screen for 10 seconds and is only shown the first five times your share a Slide Show.



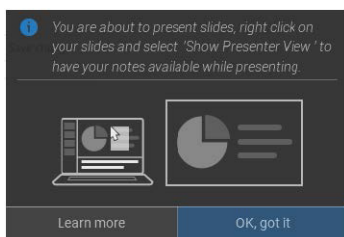

## Presenter mode on Windows

1. Open your PowerPoint and start your Slide Show. This will show your presentation full screen on your PC.
2. With a Button plugged in or the ClickShare app ready to share, select *Share an application* from the hamburger menu.

An overview of the current available application on your laptop will be displayed.

3. Select the PowerPoint Slide Show to share to the meeting room display.
4. On the full screen presentation, right-click on the slide and select Show Presenter View to see speaker notes while sharing the Slide Show to the meeting room display

## Presenter mode on macOS

1. Open your PowerPoint and start your Slide Show
2. With a Button plugged in or the ClickShare app ready to share, select *Share an application* from the hamburger menu.

An overview of the current available application on your laptop will be displayed.

3. Select the PowerPoint Slide Show to share to the meeting room display
4. Right-click on the slide and select Use Presenter View to see speaker notes while sharing the Slide Show to the meeting room display

## 3.12 View room display

### About view room display

When connected to a Base Unit, you can access the content which is shown on the meeting room display by selecting *View room display*. When doing so, a new window will open in which you will find an exact copy of what is on the meeting room display. This is useful when e.g. sitting in the back of the room, when you are taking meeting notes or when you wish to share what is shown in the room (by yourself or others) to remote participants in a UC&C call.

### How to view

1. With a Button plugged in or the ClickShare desktop app ready, click on the hamburger menu and select View room display.

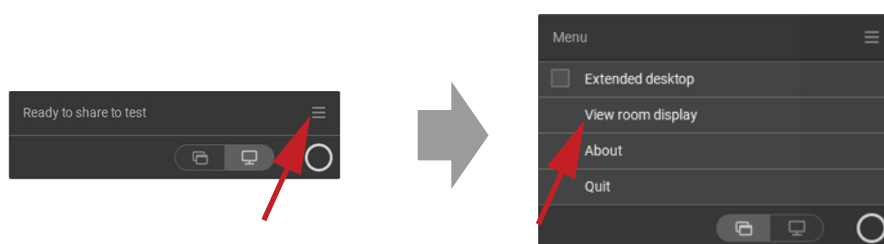

## 3.13 Stop sharing and leave

### With the ClickShare desktop app

When your meeting has come to an end, stop sharing by hovering over the red bar to expand the interface and clicking the full red circle.

Disconnect from the meeting room by either clicking the “leave room” icon (see below) or by simply closing your laptop.

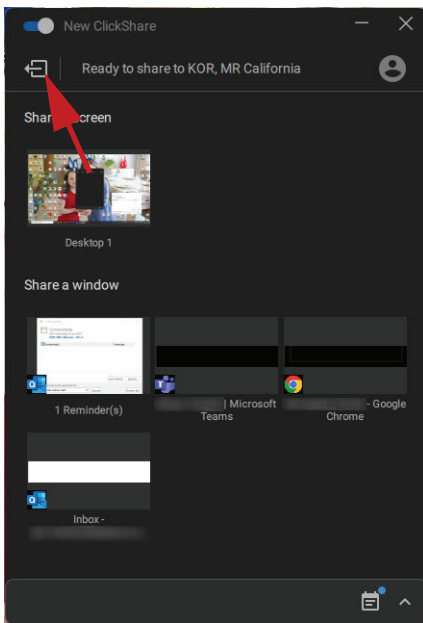


Image 3-38 Leave meeting room

### With a Button

## 3.14 Audio configuration

### Audio configuration

The connected user must control his own audio signal using the audio configuration of his computer. If he does not want to broadcast his audio signal, he has to mute audio on his computer.

For some operating system, it is necessary to set ClickShare as your default output device. Once you unplug the Button, the default setting is switched back to the previous setting. The speakerphone selection is also selected.

### Audio configuration

The following configuration is the expected configuration for the playback devices when plugging the Button. ClickShare speaker as default device and room speakerphone as default communications device.

The speakerphone is available and can be used even when not on screen. The sound coming out of the speaker is only heard when sharing content. With this defaults, the content audio will be played by the speakers and communication clients (UC&C and conferencing tools) will use the room speakerphone. For best experience, the room speakerphone should be selected in the communications client at all times. Difference is that the audio from the Speakers will be lip-synced with the content, but will have higher latency.

The communications device is optimized for the lowest latency possible, but no lip-sync is guaranteed with the video. For an optimal conference, the audio should always be transferred with lowest latency possible and will get priority over video.

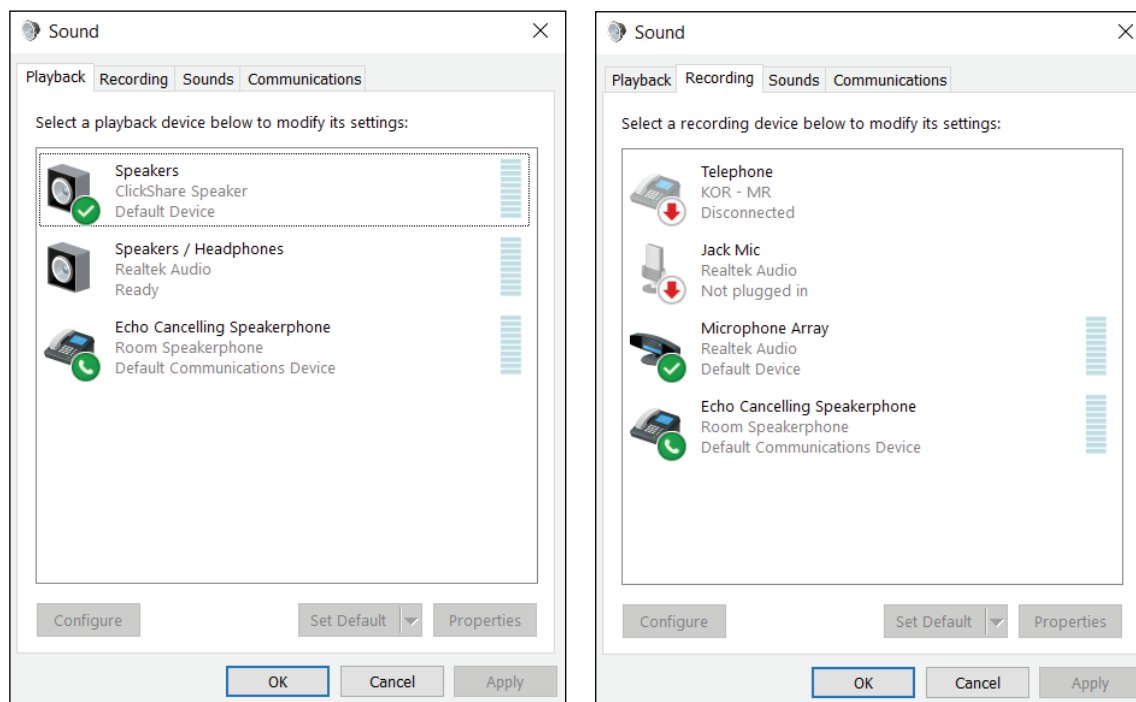


Image 3–39 Audio setup

## 3.15 Pairing

### Pairing of the Buttons with the Base Unit

To be able to use a Button it should be assigned to the Base Unit you are using. This process is called pairing. All Buttons will need to be updated and paired before use.

In case you buy additional Buttons or when a Button should be assigned to another Base Unit, the Button needs to be paired (again). The Button software update runs in the background and will not impact users while using the system. When downgrading or updating to an older version of the Base Unit software the Button need to be paired manually to update their software.



A Button can only be paired to one Base Unit at a time.  
The Button will always make connection to the Base Unit it was last paired to.

Pairing a Button can be done in two ways:

- by plugging the Button to the Base Unit.
- by using the Button Manager application running on your laptop.

### To pair a Button to the Base Unit by plugging in

1. Insert the Button in the USB type-C™ port available on the Base Unit you are using.

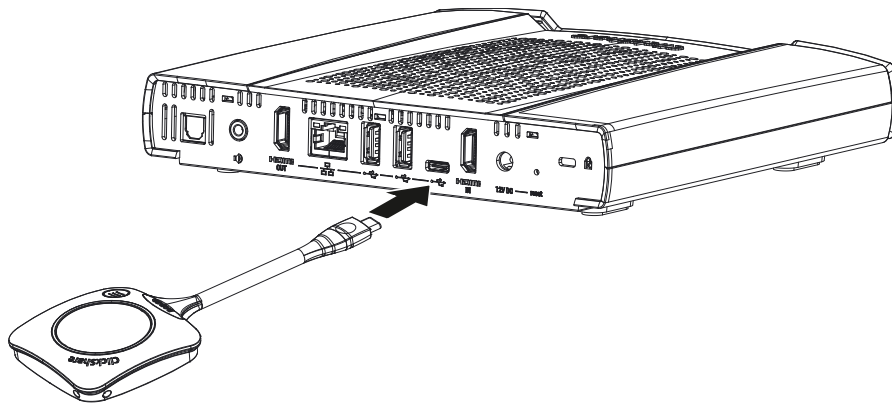


Image 3-40 Pair Button

The Base Unit LED is blinking while the Button LED fills up a circle. This means pairing is in progress.

The Base Unit automatically checks whether the software of the Button is up to date. If not, the Base Unit updates the Button software. This may take more time.

The result of the pairing process can be as follows:

- When the LEDs on the Button become green and static white on the Base Unit, the Button is paired to the Base Unit. You can unplug the Button from the Base Unit.

**2.** Unplug the Button from the Base Unit.

The Button is now ready for use.

## 3.16 Blackboarding & Annotation

### About blackboarding

Blackboarding allows you to use the meeting room's touchscreen as a writing board to write or sketch ideas on. Let creativity flow and have more dynamic meetings. With only one tap on the screen, you can save your real-time brainstorming session and share a copy with all meeting participants connected to the ClickShare Base Unit via the Button or via the ClickShare Desktop App.

With only one tap on the touch screen, you can select the blackboarding functionality. Combining a touch display and a wireless collaboration tool drives the productivity and engagement in your meeting room. With an additional tap on the screen, you can select the 'save' option. Saved sessions can be found on your laptop under `c:\Users\username\Documents\clickshare-downloads`. Files are never saved on the Button or Base Unit.

### About annotation

Annotation gives you the option to add comments directly on presented content via the meeting room's touchscreen. Discuss and make your annotations or notes on the spot, creating an elaborated environment for ideation. With only one tap on the screen, you can save your real-time brainstorming session and share a copy with all meeting participants connected to the ClickShare Base Unit via the Button or via the ClickShare Desktop App.

With only one tap on the touch screen, you can select the annotation functionality. Pick your color and you can start to draw, write, highlight. Combining a touch display and a wireless collaboration tool drives the productivity and engagement in your meeting room. With an additional tap on the screen, you can select the

'save' option. Saved annotations can be found on your laptop under `c:\Users\username\Documents\clickshare-downloads`. Files are never saved on the Button or Base Unit.

### 3.16.1 Start the blackboarding or annotation mode

#### How to start

1. Click on the blackboarding icon in the permanent bar (1).

The selection menu with *Blackboard* and *Annotation* opens on the current presented content. When nothing is shared, only *Blackboard* will be available in the menu.

2. To start annotation, click on the annotation icon in the permanent bar (2).

No clients should be disconnected. The current shared screen(s) will be captured and used as background. No previous content can be shown again.

### 3.16.2 Drawing tools

#### Pen

Click on the Pen icon (3) to start the drawing functionality. Draw with your finger on the screen.

## Erase

Click on the Erase icon (2) to start the erase functionality. Erasing can be done with single finger or with multiple fingers. The eraser grows in size depending on the speed of the movement. The erased parts are indicated with a circular overlay.

## Color

Allows you to switch between the different pen colors (1). The default color is red.

Tap on the Color icon to change the drawing color.

- black
- red
- blue
- green

Tap on the desired color to change the pen color. The current select color in the toolbar will change to the new selection. The current selected is highlighted.

## Clear

Click on the Clear icon (3) to clear the current drawing. A warning message “Are you sure you want to clear the page?” will be displayed.


Click on **OK** to clear the content.

Click on **Cancel** to keep the content.

### 3.16.3 Saving a drawing on a USB stick

#### How to save

1. Insert a USB stick in one of the USB inputs of the Base Unit.

 *Note:* USB stick must be formatted with FAT32.

2. Click on **Save** icon (reference 4, [Image 3–44](#)).

The current drawing is saved on the USB stick as PDF with as file name the meeting room name and current date.

When saving a blackboard drawing, the white and the black lines are inverted. The white annotations become black and the black annotations become white.

### 3.16.4 Saving a drawing to connected clients

#### How to save

1. Click on **Save** icon (reference 4, [Image 3–44](#)).

The Base Unit checks whether there are Buttons connected.

The connected client will receive a pop-up message requesting to save the file on his device.

**2.** Accept the blackboard file.

The Base Unit will transfer the file to the Button client and the file will be saved on the user's device within the user's home folder. The file will be saved as a PDF file with as file name the meeting room and current date.



When there is also an USB stick (FAT32 formatted) inserted in the Base Unit, the file will be saved on this USB stick at the same time.

### 3.16.5 Returning to Presenter mode

#### How to return

**1.** Click on the **Close** (Cross) button in the lower right corner.

The Base Unit returns to Presenter mode.

The content of the Blackboard is not cleared. When returning to the blackboarding mode, the previous content will be displayed.

The content of the Annotation mode is cleared and cannot be reused when restarting the annotation mode.

## 3.17 Touch Back

### About Touch Back

Touch Back support on your wireless collaboration solution allows you to control any application on your laptop via the touch screen in the room, instead of using a computer mouse or clickers. You can control data with your finger or with a specified stylus. Stay in control of your presentation, and don't let technical limitations interrupt the flow of your meeting anymore.

No need to go back to your laptop or use unreliable clickers to move to the next slide. Simply tap the screen to switch slides. And with a few touches on the screen, you can also open other presentations, share mails or start a video. With one tap on a touch screen, you can also select the blackboarding or annotation functionality. The combination of a touch display and a wireless collaboration tool drives the productivity and engagement in your meeting room.

- It gives you the opportunity to present more freely within the meeting space
- You can start to ideate on content real-time.
- Collaborate more interactive and creatively.
- Get higher engagement from the participants.
- Technical limitations of the room are not hindering the flow of the presentation or meeting.
- It boosts spontaneous collaboration, giving people the opportunity to use the specific extras like easy access to online content, cloud drives or photos, zoom, annotate, blackboarding...

### What you need to use Touch Back

- You need a Button successfully paired and updated with the corresponding Base Unit.
- A supported touch panel display. A list of supported displays is listed on Barco's website in "*The ClickShare Supported Touch Panels Whitepaper*".

### How to use Touch Back

- Tap once to control your laptop instead of using the computer mouse.
- To right-click, the touchscreen needs to be pressed for about 2-3 seconds long.
- Touchback can be enabled/disabled by touching the icon on the bottom right on the meeting room display

## Points to know

- The best performance is achieved by sharing without audio.
- When sharing the extended desktop, a small lag might be observed.
- Native touchscreen functionalities cannot be used in combination with Touch Back. Ideally, they need to be disabled.
- You can disable touch back when presenting by clicking the touch back icon in the permanent bar at the bottom of the display.

## 3.18 Room Dock

### About

Room Dock allows to create a wireless bridge for echo-cancelling speakerphone and USB camera attached to the Base Unit. This allows the user to take advantage of the installed meeting room peripherals to have better audio and video conferencing using their typical videoconferencing tools like Skype or Zoom.

The echo-cancelling speakerphone and USB camera is accessible to any user that has a Button plugged in or a ClickShare desktop app installed..

## 3.19 Airplay


### About Airplay

Airplay is a protocol that allows wireless streaming between devices of audio, video, device screens and photos. The ClickShare Base Unit can be configured to receive the airplay streaming

### Why Airplay

You want to show multiple people your photos and videos or your PowerPoint and Keynote presentation on a big screen? Connect your device to the ClickShare Base Unit which can be configured to receive the Airplay streaming.

### How to use Airplay

1. Make sure your device is connected with the ClickShare WiFi in the meeting room.
2. Open the control panel of your device and swipe up from the bottom left of the screen or swipe down from the top right of the screen, depending of your device.
3. Click on  Synchronise display and select the ClickShare device in the meeting room.

For more information about using Airplay with a typical device, consult the user manual of that device.

## 3.20 Chromecast

### About Chromecast

Chromecast is a protocol that allows wireless streaming between devices of audio, video, device screens and photos. The ClickShare Base Unit can be configured to receive the Chromecast streaming.

### Why Chromecast

You want to show multiple people your photos and videos or your PowerPoint and Keynote presentation on a big screen? Connect your device to the ClickShare Base Unit which can be configured to receive the Chromecast streaming.

### How to use Chromecast

1. Make sure your device is connected with the ClickShare WiFi in the meeting room.
2. Click on the cast-icon to display the content of you device on the meeting room screen.



For more information about using Chromecast with a typical device, consult the user manual of that device.

## 3.21 Miracast

### About Miracast

Miracast enables seamless display of multimedia content between Miracast devices. Miracast allows users to wireless share multimedia, including high-resolution pictures and high-definition (HD) video content between Wi-Fi devices, even if a Wi-Fi network is not available. Miracast creates its own direct wireless signal between your mobile device and the wireless display receiver (ClickShare Base Unit).

### How to use Miracast

1. Miracast should be enabled on the ClickShare Base Unit.
2. Your mobile device needs to be Miracast enabled. Devices like Samsung smartphones or other Android phones, as well as devices that use Windows 8 or 10, typically have the technology built-in.
3. In the settings of your mobile device, open 'wireless display' (name can be different depending on the device type and model). See the device's user guide.
4. Select the ClickShare Base Unit in the meeting room.



# Troubleshooting

# 4

## 4.1 Basic troubleshooting

### Problem solving

In this chapter some problems that might occur while using CX-50 are listed. For each problem possible causes are given and a solution is proposed. If you cannot solve the problem yourself, please contact your local IT administrator.

### Generic issues
