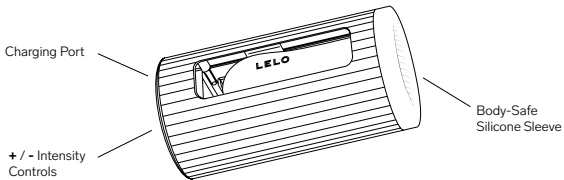
Congratulations on acquiring the F1S V2. Before getting more closely acquainted with it, please take a moment to look through this user manual.

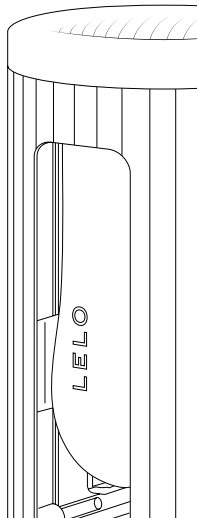

Instead of standard vibrations, F1S V2 emits powerful sonic waves that permeate deep into your penis, making it feel as though it's resonating from all directions all at once. And with the LELO app, you can adjust the intensity to your liking.

### **Cruise Control™** TECHNOLOGY

Cruise Control is a fully automatic function designed to detect any slowing motion of the dual motors and can boost the power up again via PWM (Pulse Wave Modulation). In doing so, Cruise Control ensures that you enjoy consistent power and intensity, no matter what.



## USING YOUR F1S V2

### HOW TO USE YOUR PRODUCT **WITHOUT THE APP**

- Before the first use, charge your F1S V2 for 2 hours.
- Press the center button for 1 second to turn it on.
- The LED lights will blink, showing the battery level.
- The LED lights will go steady, showing the vibration level.
- Press the + or – button to adjust the vibration intensity.
- Press the center button for 3 seconds to turn it off.
- Press and hold the + and - buttons simultaneously for 5 seconds to lock your F1S V2 and avoid unintended activation.

### HOW TO USE YOUR PRODUCT **WITH THE APP**

- Before the first use, charge your F1S V2 for 2 hours.
- Press the center button for 3 seconds to turn it on while activating the Bluetooth.
- All the LED lights will blink simultaneously showing the Bluetooth pairing.
- Open the F1S APP and once the confirmation message appears, press the center button of the product to confirm.
- All the LED lights will go steady, showing the connection was successful.
- If the connection fails, your product will automatically turn off after 30 seconds.
- The battery and vibration level will be available in the app.

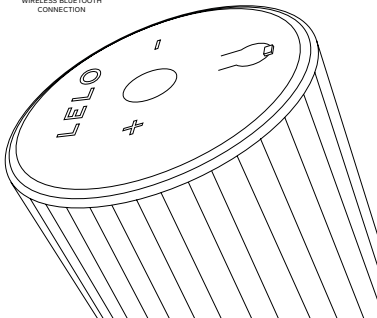

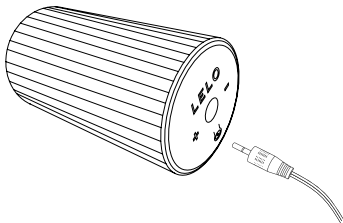

## CHARGING YOUR F1S V2 Smart Male Trainer

- Insert the DC plug into the DC port at the top of your F1S V2.
- The LED on the interface of your F1S V2 will pulse to indicate it is charging. When it is fully charged (after c. 2 hours), the LED will emit a steady glow.
- When the battery is running low, the LED on your F1S V2 will emit a blinking white light.



**Only use original chargers provided by LELO with your F1S V2.**



## **CLEANING, STORAGE AND SAFETY**

Proper care and maintenance will help extend the lifetime of your F1S V2 trainer.

Using F1S V2 with hand creams or silicone-based lubricants may make the silicone permanently tacky.

F1S V2 is fully waterproof, making cleaning simple. Rinse and spray with LELO Toy Cleaner, then rinse again and allow to dry. A cotton swab can be used to clean the inside of the 'mouth'.

Always clean your F1S V2 thoroughly before and after each use. You can wash the silicone with warm water and antibacterial soap, rinse with clean hot water, and pat dry with a lint-free cloth or towel. Never use cleansers containing alcohol, petrol, or acetone.

Avoid leaving your F1S V2 trainer in direct sunlight and NEVER expose it to extreme heat. Store your F1S V2 in a dust-free place and keep it away from products of other materials.

**IMPORTANT:** Children shall not play with the appliance. For adult use only. Those who may be pregnant, have a pacemaker, diabetes, phlebitis, thrombosis or any other condition, should consult with a medical professional regarding the risk of blood clots before using any personal massage product.

**The appliances must only be supplied at SELV.**

## TROUBLESHOOTING

### **The LED on your F1S V2 does not pulse when the charger is connected?**

- Battery is drained and will require several minutes to acknowledge that it is being charged.
- Charger is not properly connected. Check wall and DC sockets.

### **Your F1S V2 does not activate when the center button is pressed?**

- The battery is empty. Recharge your F1S V2.
- The interface of your F1S V2 is locked. Hold down **+** and **-** for 5 seconds.
