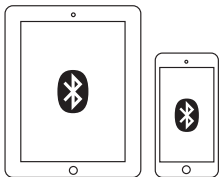

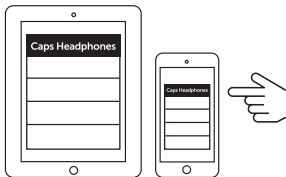
1. Fully charge your Caps Headphones before use.

3. Enable Bluetooth on your tablet or smartphone.



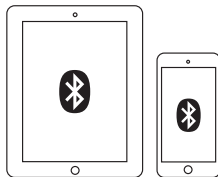
4. Select the Caps Headphones from the list of Bluetooth devices.
