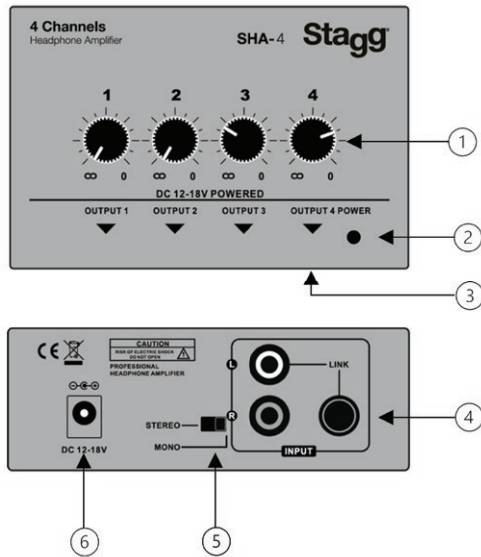
Please read the instructions carefully before use

SAFETY INSTRUCTIONS

Please read the instructions carefully as they include important information about the installation, operation and maintenance.

- Please keep this user's guide for future consultation. If you sell the unit to another user, make sure that they also receive this instruction booklet.
- All products leave the manufacturer intact. Please note that damage incurred by the user is not covered by the warranty.
- Unpack and check carefully for any transport damage before using the unit.
- The unit is for indoor use only. Use only in a dry location.
- Before use, ensure that the voltage and frequency of the power supply match the power requirements of the unit.
- Do not operate the unit if the ambient temperature is above 45°C.
- Never operate for a long time to avoid shortening lifespan. Do not allow any flammable liquids, water or metal objects to enter the unit. If this happens, turn off the mains power immediately.
- Do not touch any wire during operation as there may be a risk of electric shock.
- In the event of a serious operating problem, stop using the unit immediately.
- Never switch the unit on and off repeatedly.
- Do not open the unit as there are no user serviceable parts inside.
- Never attempt to repair the unit yourself. Repairs carried out by unqualified persons may cause damage or malfunction. Please contact the nearest authorized technical support centre.
- Use the original packaging for transport in the event of a problem covered by the warranty.
- Never operate the SHA-4 with a headphone or other accessories at high volume levels. Hearing experts advise against continuous operation at high volume. If you experience ringing in your ears, reduce the volume level or discontinue use.

CONTROLS

- 1 VOLUME : Adjusts the output level of each headphone individually.
- 2 POWER STATUS : LED Lights up when the device is switched on.
- 3 HEADPHONES OUTPUTS : 4x TRS Jacks 6,3mm (1/4") plug outputs.
- 4 INPUT SECTION: 2x RCA connectors + 1x TRS Jack 6,3mm (1/4") plug.

RCA's and jack are linked together. If one of the two solutions is used, the signal can be sent to another device via the free connector.

- 5 MODE : Switch between stereo or mono routing.
- 6 DC IN : Connector for a 12V (Min 150mA) power adapter.
