1.2 Installation Instructions

Leave the monitor in its protective foam packaging. Align the latches of the stand to the monitor. Tighten the stand with screws.

Connect the stand base to the stand and tighten the screw to secure the stand base.

Align the latches to place the stand cover.

Adjust the angle of the stand, make sure the stand assembly is properly installed before setting the monitor upright.

Important

Remove the screws on the monitor groove if needed before installing the stand.

Place the monitor on a soft, protected surface to avoid scratching the display panel.

Do not use any sharp objects on the panel.

The groove for installing the stand bracket can also be used for wall mount. Please contact your dealer for proper wall mount kit.



Chapter 4 Adjusting the Viewing Angle

For optimal viewing, it is recommended to look at the full face of the monitor, and then adjust the monitor's angle to your own preference.

Hold the stand so you do not topple the monitor when you adjust the monitor's angle.


You are able to adjust the tilted angle from -5° to 23°.





Avoid touching the display panel when adjusting the monitor.

You are able to swivel the monitor for the angle.




NOTE:

Do not touch the LCD screen when you adjust the angle. It may cause damage or break the LCD screen.

Careful attention is required not to catch your fingers or hands when you adjust the angle.

Chapter 5 Connecting the Monitor

- 1. Turn off your computer.
- 2. Connect the video cable from the monitor to your computer.
- 3. Connect the power cord to the monitor power jack.
- 4. Plug the power cord into the electrical outlet.
- 5. Turn on the monitor.
- 6. Power on the computer and the monitor will auto detect the signal source.
- **7.** Plug one end of the DisplayPort/HDMI cable to the monitor's DisplayPort/HDMI port. *Use either the HDMI or DisplayPort connection for display.
- 8. Connect the other end of the DisplayPort/HDMI cable to your computer's DisplayPort/HDMI port.



Make sure that the power voltage is within its safety range and has been adjusted properly to the value of 100~240V before connecting the device to the power outlet.
