OPERATING INSTRUCTIONS

This appliance is intended for household use only.

The appearance of this appliance may differ from the illustration.

Only use this appliance for its intended purpose as described in this manual. Do not use attachments not recommended by the manufacturer.

HOW TO USE

Place the appliance on a flat, level, solid floor.

FILLING THE UNIT

- Before filling the unit ensure that it is not plugged into the mains.
- Fill the unit with water at the desired temperature.
- The water level indicator on the inside of the footbath (maximum filling level of approx. 1.9 liters) should not be exceeded.
- 4. For any usage, the appliance should always be filled with water.

SWITCHING ON

- Never use the appliance in a standing position or stand up in the unit, as too much pressure will cause the unit to crack.

AFTER USE
